HIGHWAYS ACT 1990

The Leicestershire County Council (Syston Northern By-pass (A607) Classified Road) (Side Roads) Order 1990

The Secretary of State for Transport hereby gives notice that he has confirmed with modifications the above Order which was made by the County Council of Leicestershire under sections 14 and 125 of the Highways Act 1980 and which, as confirmed, provides for authorising the Council.

- (a) to improve highways,
- (b) to stop-up highways,
- (c) to construct new highways,
- (d) to stop-up private means of access to premises, and
- (e) to provide new means of access to premises,

all on or in the vicinity of the route of the classified road which the Council are proposing to construct from the Fosseway (B6670) at its existing junction with Cossington Lane eastwards to its junction with Melton Road (A607) at the existing junction of the said Melton Road with Rearsby Road.

Copies of the Order (as confirmed) and of the relevant plans may be inspected free of charge at all reasonable hours at the offices of the Leicestershire County Council, Room No. 1, County Hall, Glenfield, Leicester, and at the offices of Charnwood Borough Council, Council Offices, Southfields, Loughborough.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the Highways Act 1980 or on the ground that any requirement of that Act or of any regulations made thereunder has not been complied with in relation to the Order, may, within 6 weeks of the 25th June 1991, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

Notification by a Public Gas Supplier of Intention to Execute Works for the Construction of High Pressure Pipelines

In accordance with section 20(1) of the Gas Act 1986 (c44), the Director General of Gas Supply has received notices from British Gas plc, a public gas supplier within the meaning of that Act, of its intention to execute works for the construction of high-pressure

pipelines for the conveyance of Natural Gas or Substitute Natural Gas, as follows:

Copies of the notices, and of the accompanying maps delineating the route which the proposed pipelines are to take, may be inspected free of charge, between 10 a.m. and 4 p.m. Monday to Friday, in the Library of the Office of Gas Supply, Southside, 105 Victoria Street, London SW1E 6QT (telephone 071-828 0898 for an appointment). Copies may also be purchased from the Library, at a cost of £1 for up to and including five pages, and £0.10 per page thereafter (including VAT), by personal callers between the times given above, or by postal request made payable to the Office of Gas Supply.

Sections 20(4) and (5) of the Gas Act 1986, provide that the Director General of Gas Supply may give directions as to the capacity of a proposed pipeline and as to the cost of its construction, if satisfied in the light of representations;

- (a) that a demand exists or is likely to arise for the conveyance of gas of, or of a kind similar to, the kind specified in the notice relating to a proposed pipeline; and
- (b) that the routes along which the gas will require to be conveyed will severally be, as to the whole or any part thereof, the same or substantially the same as the route or any part of the route so specified.

Any representations as to such matters should be made in writing and delivered to the Director General of Gas Supply, Office of Gas Supply, Southside, 105 Victoria Street, London SW1E 6QT in such manner that.

- (a) an indication in respect of the gas for the conveyance of which a demand may exist or be likely to arise, of
 - (i) its origin
 - (ii) its quantity; and
 - (iii) the rate at which it may be conveyed,
- is delivered within 28 days of publication of this notice; and
- (b) any other and further representations are delivered within 90 days of publication. (5 SI)
