*The City of Cambridge Area E (Consolidation) Order 1991  
(Amendment No. 6) Order 1991*

Notice is hereby given that Cambridge City Council ("the Council") in pursuance of arrangements made under section 101 of the Local Government Act 1972 with Cambridgeshire County Council in exercise of the powers of the said County Council under sections 1, 2, 3, 4 and 64 of the Road Traffic Regulation Act 1984 ("the Act of 1984") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 intend making the above-named Order.

The effect of the Order is to amend The City of Cambridge Area E Consolidation Order 1991 to introduce 24 hour waiting restrictions on both sides of Malvern Road from point 83 metres from the centreline of Mill End Road for a distance of 53 metres in a westerly and northerly direction.

*The Colchester Borough (Grove Road, Tiptree) (Restriction of  
Waiting Order 1991*

Notice is hereby given that the Colchester Borough Council, as agents for the Essex County Council, propose to make an Order under section 1 of the Road Traffic Regulation Act 1984, the effect of which will prohibit the waiting of vehicles in Grove Road, Tiptree, on its south side from a point 15 metres north-east of its junction with Church Road north-eastwards for a distance of 44 metres, between the hours of 8 a.m. to 6 p.m., Mondays to Saturdays inclusive.

## COLCHESTER BOROUGH COUNCIL

*The Colchester Borough (Various Roads, Colchester) (Prohibition  
and Restriction of Waiting) Order 1991*

Notice is hereby given that the Colchester Borough Council, as agent for the Essex County Council, proposes to make an Order under section 1 of the Road Traffic Regulation Act 1984, which provides, respectively:

To prohibit waiting at all times on specified sides and lengths of the roads in Schedule 1 to this Notice.

To prohibit waiting between the hours of 8 a.m. and 6 p.m., Mondays to Saturdays, inclusive, on specified sides and lengths of the roads in Schedule 2 to this Notice.

To prohibit waiting between the hours of 8 a.m. and 6 p.m., Mondays to Fridays inclusive in Mason Road, Colchester from its junction with the Cowdray Avenue service road on both sides for its entire length.

To prohibit waiting between the hours of 9 a.m. and 10 a.m., Mondays to Fridays inclusive in Mile End Road, Colchester on its east side from a point 160 metres north of its junction with Turner Road northwards to a point 15 metres south of its junction with Tall Trees and in Rectory Close, Colchester on both sides for its entire length.

To prohibit waiting between the hours of 2 p.m. and 3 p.m., Mondays to Fridays inclusive in Clarendon Way, Colchester on its north side from a point 18.3 metres east of its junction with North Station Road, eastwards for a distance of 58 metres.

The Order will not prevent vehicles waiting for the purpose of loading or unloading goods, allowing passengers to board or alight or to enable works to be carried out in the road. Exemptions in the Order also permit the waiting of disabled persons' vehicles in accordance with the orange badge Scheme.

A copy of the Order, with details of the specified lengths of roads, a map showing the lengths of roads to which the Order relates and a copy of the Council's reasons for proposing to make the Order may be inspected at the Council offices in Angel Court, High Street, Colchester between 9 a.m. and 5 p.m., Mondays to Fridays. Copies are also available for public inspection during normal office hours at the Local Government Library (E Block), County Hall, Chelmsford.

## DERBYSHIRE COUNTY COUNCIL
