The new Order will come into operation on 25th June 1992, and has the part effect as described in issue 52698 of the *London Gazette* (ref. 488).

The Order has been amended to include the following restrictions:

1. the deletion from the Third Schedule of the Order of 1967 the waiting restrictions between 7 a.m. and 6 p.m., Mondays to Saturdays inclusive on the north side of Lanehouse Road, from the junction with Westbury Street/Thorntree Road, for a distance of approximately 61 metres to the west.
2. the addition of a Fourth Schedule to the Order of 1967 containing waiting restrictions for a period of up to 30 minutes with no return within two hours from the last period of waiting, on that length of road adjacent to numbers 109 and numbers 111 Lanehouse Road.

If you wish to question the validity of the Order, or any of the provisions contained therein on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act or any Instrument made under it has not been complied with in relation to the Order, you may, within 6 weeks from the date of this notice, apply to the High Court for this purpose.
