

- (iv) *South Parade*, this road will be made available for two-way traffic in the short length between Middle Way and Stratfield Road. A 24-hour waiting prohibition will be introduced at the Middle Way and Stratfield Road junctions. This will reduce the available designated on-street parking area;
- (v) *Squitchey Lane*, left turns for motor vehicles from the road into Woodstock Road will be prohibited. A waiting prohibition is proposed at the junction with Paddox Close and Middle Way;
- (vi) *Stratfield Road*, this road will be made two-way for all traffic throughout its whole length. There will be a no entry for motor vehicles from South Parade into the Road. A doctors' parking space on the west side of the road 10 metres north of Oakthorpe Road will be controlled by traffic Order.
- (d) *Cycling on the Pavement*, Cycling will be permitted on the pavement on both sides of Woodstock Road from Squitchey Lane to First Turn. The pavement will be marked out for pedestrians and for cyclists.

Full details of the proposals may be seen on plans which are available for inspection at my office at the address given below between the hours of 9 a.m. and 4 p.m. on Mondays to Fridays. In the case of the proposals described in paragraph 1(c) the Orders which would introduce them are entitled "The City of Oxford (Summertown Controlled Parking Zone) Order 1992" and "The City of Oxford (Banbury Road and Woodstock Road Side Road Junctions) (Traffic Management) Order 1992". A copy of these Orders and of the Council's statement of reasons for proposing to make them may also be examined in my office between the hours mentioned above.
