TOWN AND COUNTRY PLANNING ACT 1990

The Secretary of State for Transport hereby gives notice that he proposes to make an Order under section 247 of the above Act to authorise the stopping up of an area of highway verge fronting Vauxhall Regis Garage at the corner of Shripney Road and Brooks Lane West at Bognor Regis in the county of West Sussex to enable development consisting of the extension of the existing car sales forecourt to be carried out in accordance with planning permission granted by Arun District Council under Part III of the said Act.

Proposed Stopping-up of Highways at Salford
