Fryent Way, with its junction with Salmon Street and a point 620 metres north-west of the north-western boundary of Nos. 1 to 15 Paddocks Green, Salmon Street.

Harrow Road: (a) the north-east side, between its junction with Wembley Hill Road and a point opposite the party wall of Nos.4 and 6 Harrow Road;

Salmon Street, between a point opposite the north-eastern wall of Nos. 11 to 14 Kingsmere Court, Salmon Street and the north-western kerb-line of Tudor Gardens excluding the service road fronting Nos. 39 to 77 Salmon Street and the service road rear Nos.77 to 87 The Paddocks.

and in the first 18.29 metres of adjacent Deanscroft Avenue and Queens Walk.

The carriageway immediately surrounding the island site situated at the junction of Salmon Street, The Paddocks and Fryent Way. St. Michael's Avenue:

(i) between its junction with Wembley Hill Road and a point opposite the north-eastern wall of No.12 Wembley Park Drive;

(ii) between a point opposite the party wall of Nos. 92 and 92 Wembley Park Drive and a point opposite the party of Nos. 87 and 89 Wembley Park Drive.

and in the first 18.29 metres of adjacent Manor Drive (from its junction with Wembley Park Drive).

Preston Road:

(a) the east side, between its junction with Forty Avenue and a point opposite the party wall of Nos. 10 and 12 Preston Road;(b) the west side, between its junction with East Lane and a point opposite the northern wall of No.8 Preston Road.

and in the first 18.29 metres of adjacent East Lane (north-west side) and Forty Avenue (north-west side) from its junction with Preston Road).
