TOWN AND COUNTRY PLANNING ACT 1990

The Secretary of State for Transport hereby gives notice that he has made an Order under section 247 of the above Act entitled "The Stopping-up of Highways (City of Birmingham) (No. 8) Order 1993", authorising the stopping-up of a length of footway of Woodridge Road of Aston, in the City of Birmingham.

The Order as made, will authorise the stopping-up only to enable the development described in the Schedule to this notice to take place.
