*The A470 Trunk Road (Cefn Coed, Mid Glamorgan) (Prohibition and Restriction of Waiting) Order 199*

Notice is hereby given that the Secretary of State for Wales proposes to make an Order under sections 1, 2, 4 and 124 of the Road Traffic Regulation Act 1984.

The effect of the proposed Order will be to change the waiting restriction on the side of the trunk road specified in the Schedule to this notice, from waiting restricted to a maximum of 30 minutes in any period of 60 minutes between 8 a.m. to 7 p.m. to a prohibition of waiting at any time (with certain exemptions). The current waiting restriction is imposed by the Trunk Roads (Cefn Coed, Breconshire) (Prohibition and Restriction of Waiting) Order 1973, which also imposes waiting restrictions/prohibitions on contiguous lengths of the trunk road, and the relevant provisions of which will be revoked and re-enacted, amended as necessary, by the proposed Order.

During a period of 21 days from 18th October 1994, a copy of the proposed Order, the Order being revoked, together with a plan and the statement of reasons for the making of the proposed Order may be inspected, free of charge, during normal office hours at the offices of Merthyr Tydfil Borough Council, Civic Centre, Castle Street, Merthyr Tydfil, Mid Glamorgan.

Objections, specifying the grounds on which they are made, and quoting reference ZC 510-2-5-22 must be sent in writing to the Welsh Office, Highways Directorate, Roads Administration Division, Phase 1, Government Buildings, Ty Glas Road, Llanishen, Cardiff CF4 5PL, by 8th November 1994. In the preparation of an objection and the statement of grounds of objection it should be borne in mind that the substance of any objection or representation may be communicated to other people who may be affected by it.

The Secretary of State for Transport hereby gives notice that he proposes to make the following Scheme and Orders:

*The A1 Motorway (Dishforth to North of Leeming Section and Connecting Roads) Scheme 19*

A Scheme under sections 16, 17 and 19 of the Highways Act 1980 authorising him to provide for the exclusive use of traffic of Classes I and II of the classes of traffic set out in Schedule 4 to the Highways Act 1980 a special road ("the motorway") about 21.77 kilometres in length from a point on the A1 Trunk Road 165 metres north of where it crosses the C233 Dishforth Road going in a generally north-north-westerly direction to a point 250 metres south of the entrance
