UNIVERSITIES OF OXFORD AND CAMBRIDGE ACT 1923

A Statute made by the Governing Body of the University of Cambridge, on 18th August 1995, amending Statutes B, D and T, has been submitted for the approval of Her Majesty in Council, and notice of its having been so submitted is published in accordance with the provisions of the Universities of Oxford and Cambridge Act 1923.

The main purpose of the Statute is to make amendments concerning University Officers and their duties, consequential upon the introduction of the new constitutional framework. (6 SI)
