WATER INDUSTRY ACT 1991, SECTION 19(1)(b)

Consumers in the Exeter, Bideford and Tavistock areas who might be affected by investigative work being carried out by South West Water Services Limited affecting its Bideford (307), Tavistock (403) and Exeter—Dane's Castle (603/A) Water Supply Zones will wish to be aware of the following information.

Although the water has at all times been, and remains, safe to drink, the Company has found through its water monitoring programme that water supplied from these zones has on occasion not met the standard for lead (as required by the Water Supply (Water Quality) Regulations 1989). The Secretary of State for the Environment, therefore, notified the Company that he will, if necessary, order it to take appropriate steps to ensure that the water supplied will in future meet the required standard.

The Company has given the Secretary of State a legally binding undertaking to carry out appropriate remedial work at its works to be completed by 12th February 1996. The Secretary of State has informed the Company that he is satisfied by serving on them the notice printed below:

WATER INDUSTRY ACT 1991, SECTION 19(1)(b)

The Secretary of State for the Environment:

1. Is satisfied that South West Water Services Limited "the Company" in supplying water to Bideford (307), Tavistock (403) and Exeter—Dane's Castle (603/A) Water Supply Zones has contravened and is likely to do so again its duty to supply wholesale water under section 68(1)(a) of the Water Industry Act 1991, and the requirement of Regulation 3(3)(c) of the Water Supply (Water Quality) Regulations 1989, that water supplied should not contain lead at a greater concentration than 50µg/litre.
2. Has notified South West Water Services Limited on 4th August 1995 that he is considering making in relation to the Company an Enforcement Order under section 18 of the Water Industry Act 1991.
