TOWN AND COUNTRY PLANNING ACT 1990

Amendment to loading restrictions in London Wall

The hours during which the prohibition on vehicles waiting for the purpose of delivering or collecting goods or loading or unloading a vehicle for a period of more than 20 minutes in the same place apply will be changed so that the prohibition will apply between 11 a.m. and 4.30 p.m. on Mondays to Fridays inclusive and between 11 a.m. and 1.30 p.m. on Saturdays.

The Order also contains drafting amendments which do not affect the existing restrictions and takes into account the renaming of part of Whitecross Street to Silk Street.

(iv) the revocation of the existing one-way northerly restriction at Little Bedford Street between Saville Street and Wellington Street and its replacement by a southerly one-way system.

(4) Provide for:

- (i) the removal of 8 "pay and display" spaces on west side of Bedford Street from a point 14 metres north of its junction with Saville Street to a point south of its junction with Wellington Street and their replacement by a "no waiting at any time" waiting restriction; and
- (ii) the conversion of 5 "pay and display" spaces to parking bays for disabled drivers on the north side of Saville Street from a point 15 metres from its junction with Bedford Street eastwards for a distance of 26.5 metres.

The Orders shall come into operation on 18th September 1996.

PLANNING (LISTED BUILDINGS AND CONSERVATION AREAS) ACT 1990

Extension to Boughton Conservation Area

Notice is hereby given under the Planning (Listed Buildings and Conservation Areas) Act 1990, section 69, that Chester City Council ("the Council") varied the Boughton Conservation Area ("the Conservation Area"), on 4th June 1996. The Conservation Area was varied by the inclusion within it of:

Planning applications for development which would, in the opinion of the local planning authority, affect the character or appearance of the Conservation Area, must be given publicity, and representations received as a result of the publicity must be taken into account in determining the application;

It becomes an offence, subject to certain exceptions, to cut down, lop, uproot, wilfully damage or wilfully destroy any tree in the area except with the consent of the local planning authority;

The local planning authority are now under a duty to formulate and publish proposals for the preservation and enhancement of the area.

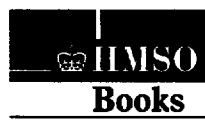
