- (b) designate new parking places in Addiscombe Court Road, East Croydon (outside No. 147); Beechwood Avenue, Thornton Heath (outside No. 36); Beverstone Road, Thornton Heath (outside No. 74); Crowley Crescent, Croydon (outside No. 67); Davidson Road, East Croydon (outside No. 203); Dovercourt Avenue, Thornton Heath (outside No. 19); Fairchildes Avenue, New Addington (outside No. 46); Freeland Avenue, Croydon (outside Nos. 2 to 24 and outside No. 5); Kimberley Road, Thornton Heath (outside Nos. 63 and 78); King Henry's Drive, New Addington (opposite No. 377, outside No. 473); Lancing Road, Thornton Heath (outside No. 59); Lindfield Road, Woodside (outside Nos. 1 and 7); Nova Road, Thornton Heath (outside No. 5); Ockley Road, Croydon (outside No. 74); Quadrant Road, Thornton Heath (outside No. 4); Redford Avenue, Thornton Heath (outside No. 23); Rosecourt Road, Thornton Heath (outside No. 33); Sandfield Road, Thornton Heath (outside No. 17); Sherwood Road, Croydon (outside No. 57); Stroud Road, Woodside (outside No. 38); Sundridge Road, Addiscombe (outside No. 47) and Whitehall Road, Thornton Heath (outside No. 43);
- (c) provide that the parking places would operate "At Any Time";
- (d) specify, in respect of the parking places, that disabled persons' vehicles displaying in the relevant position a disabled persons' badge (commonly referred to as the "Orange Badge") issued by any local authority under the provisions of the Disabled Persons (Badges for Motor Vehicles) Regulations 1975 or 1982, as amended, may be left therein; and
- (e) provide that certain vehicles may wait in the parking places in certain circumstances, e.g. to allow persons to board or alight (maximum 2 minutes), to load or unload (maximum 20 minutes), etc.
