The A470 Trunk Road (Pentrebach-Cefn Coed, Merthyr Tydfil) (Prohibition of Pedestrians) Order 1996

Notice is hereby given that the Secretary of State for Wales proposes to make an Order under sections 1 and 2 of the Road Traffic Regulation Act 1984.

The effect of the proposed Order will be to prohibit pedestrians from proceeding in those lengths of the A470 Cardiff-Glan Conwy Trunk Road (hereinafter referred to as "the trunk road") specified in the Schedule to this notice.

A copy of the proposed Order, relevant plan and the statement of reasons for making the Order, may be inspected during normal office hours at the offices of Merthyr Tydfil County Borough Council,

Lengths of the trunk road between Pentrebach and Cefn Coed in the County Borough of Merthyr Tydfil.

1. That length of the trunk road which extends from a point 35 metres north-west of the centrepiece of Abercanaid Roundabout in a general north-westerly direction to a point 33 metres south-east of the centrepiece of Swansea Road Roundabout.
2. That length of the trunk road which extends from a point 33 metres north-west of the centrepiece of Swansea Road Roundabout in a general north-westerly direction to a point 35 metres south-east of the centrepiece of the A465 Heads of the Valleys Road Roundabout.
