The Stopping-up of Highways (Adopted Footpath Adjacent to Letton Road, Atlantic Wharf, Cardiff) Order 1996

The Secretary of State for Wales hereby gives notice that he has made an Order under section 247 of the Town and Country Planning Act 1990, to authorise the stopping-up of the length of highway described in the Schedule to this notice.

The stopping-up is authorised only in order to enable development, consisting of the erection of flats, to be carried out in accordance with planning permission granted by Cardiff City Council on 10th June 1996, under reference 96/00056/R. The Order shall cease to have effect upon the cessation of this planning permission.

The Order requires the provision of new highway which will be highway maintainable at public expense, for which Cardiff County Council shall be the Highway Authority.

Copies of the Order and the deposited plan may be inspected during normal office hours, at the offices of Cardiff County Council, Atlantic Wharf, Cardiff, or may be obtained, free of charge, from the Welsh Office, Highways Directorate, RA3, Cathays Park, Cardiff CF1 3NQ (quoting reference ZC 510-5-7-37).

If any person desires to question the validity of the Order, or any provisions contained therein, on the grounds that it is not within the powers of the Town and Country Planning Act 1990, or that his interests have been substantially prejudiced by a failure to comply with any requirements of the Act, he may, within 6 weeks of 14th October 1996, apply to the High Court for the suspensions or quashing of the Order or of any provision contained therein.

SCHEDULE

The highway to be stopped-up is Atlantic Wharf in Cardiff. It is shown by zebra hatching on the deposited plan and is that length of adopted footpath which extends from its junction with the southern footway of Letton Road in a general north-easterly direction for a distance of approximately 33 metres.
