### PETROLEUM AND SUBMARINE PIPE-LINE ACTS 1975

#### *Notice of the issue of a Submarine Pipe-line Works Authorisation*

The Secretary of State for Trade and Industry hereby gives notice that he has decided to issue, and in consequence has issued, a works authorisation to be held by Victoria Oilfield Development (UK) Limited, whose address is Victoria House, Scotstown Road, Bridge of Don, Aberdeen AB23 8HG, for the construction of a 191 millimetre temporary pipe-line between the semi-submersible drilling rig "Petrolia" and a moored shuttle tanker in connection with the testing of a well on the Texaco operated Mariner field.

Except with the consent of the Secretary of State, the 191 millimetre pipe-line shall only be used to convey crude oil.

The pipe-line may be used by the holder and with the holder's agreement, and with the consent of the Secretary of State, by other persons.

Victoria Oilfield Development (UK) Limited has been appointed operator of the pipe-line.
