Notice of application for Drought Permit

Notice is hereby given that, by reason of an exceptional shortage of rain, a serious deficiency of supplies of water is threatened in the water supply area of Essex and Suffolk Water Plc ("the Company") in Suffolk.

The Company is therefore applying to the Environment Agency for a drought permit under section 79A of the Water Resources Act 1991, enabling the Company to take the following measures, for a period not exceeding 6 months, to alleviate the threatened deficiency of water.

The application is to vary the licence conditions contained in licence No. 7/34/16/G/48, to permit the Company to increase the daily abstraction of water from its operational borehole at Redgrave, Suffolk, at National Grid Reference TM 0461 7923, from 3,637 cubic metres per day to 4,320 cubic metres per day, which is equivalent to an increased rate of abstraction from 42-1 litres per second to 50 litres per second. These additional supplies will provide water from Redgrave Fen to safeguard the unique environmental habitat of the fen.
