TOWN AND COUNTRY PLANNING ACT 1990

The Secretary of State for Transport hereby gives notice that he proposes to make an Order under section 247 of the above Act to authorise the stopping-up of lengths of highway at Thomas Street, Spennymoor, County Durham.

If the Order is made, the stopping-up will be authorised only in order to enable the development described in the Schedule to this notice to be carried out in accordance with the planning permission granted to Aldi Stores Ltd. by Sedgefield District Council, on 6th February 1996, under Ref. 7/95/0473/DM.

TOWN AND COUNTRY PLANNING ACT 1990

The Secretary of State for Transport hereby gives notice on the application of the Sedgefield District Council, he proposes to make an Order under section 249 of the above Act to provide for the extinguishment of any right which persons may have to use vehicles on a length of Church Street, Spennymoor, County Durham. The proposed Order will contain provisions for permitting the use of that length of highway by vehicles being used:

- (a) for Police, Ambulance or Fire Brigade purposes;
- (b) in connection with the laying, erection, inspection, maintenance, alteration, repair, renewal or removal in or near the said length of highway of any sewer, main, pipe, conduit, wire, cable or other apparatus for the supply of gas, water, electricity or of any telecommunication code systems operator;
- (c) in the service of the Local Authority in pursuance of their statutory powers and duties; and
- (d) in connection with the retail unit on the corner of High Street and Church Street.
