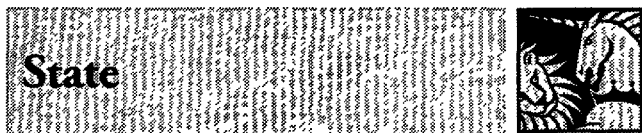

AMENDMENT TO WAITING RESTRICTIONS IN GOSWELL ROAD AND QUEEN STREET

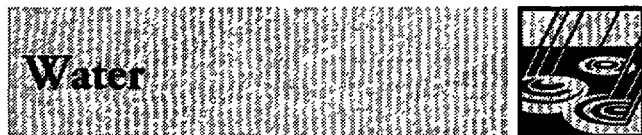

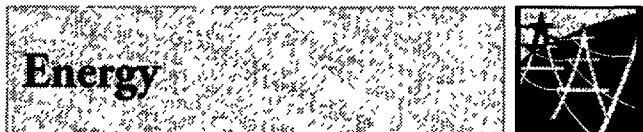
