**NOTICE OF APPLICATIONS TO STOP UP BATH STREET, CITY CENTRE; PART OF ANGEL STREET, CITY CENTRE; PARTS OF MEETINGHOUSE LANE, CITY CENTRE AND PART OF HIDES STREET, CARBROOK**

Notice is hereby given that the Sheffield City Council, being the Highway Authority for the said City, intend to apply to the Magistrates' Court sitting at Castle Street, Sheffield, on 19th October 1999, at 10 a.m. for 4 Orders under section 116 of the Highways Act 1980, that the areas of highway described in the Schedule below be authorised to be stopped-up on the ground that they are unnecessary.

- 1 The whole of *Bath Street*, off *Headford Street*.
- 2 An irregular shaped area of the western footway of *Angel Street* extending from its junction with *Bank Street* for an approximate distance of 41 metres southwards.
  - 3.1 An irregular shaped area of the eastern footway of *Meetinghouse Lane* commencing at a point approximately 9 metres south of its junction with *Bank Street* and extending for an approximate distance of 27 metres southwards.
  - 3.2 An irregular shaped area of the eastern footway of *Meetinghouse Lane* commencing at a point approximately 38 metres south of its junction with *Bank Street* and extending for an approximate distance of 16 metres southwards.
- 4 An irregular shaped area of *Hides Street* commencing at a point approximately 2.5 metres from its junction with *Attercliffe Common* and extending to its cul-de-sac ends.

**HIGHWAY AT DONIBRISTLE CROFT, CASTLE VALE, BIRMINGHAM**

The Secretary of State for the Environment, Transport and the Regions hereby gives notice that he has made an Order under section 247 of the above Act entitled "The Stopping-up of Highways (City of Birmingham) (No 12) Order 1999" authorising the stopping-up of an area of highway and the stopping-up of lengths of private access to premises at *Donibristle Croft* and requiring the provision of new highway shown as stippled on the deposited plan and the improvement of existing highway shown as cross hatched on the deposited plan.

The Order as made, will authorise the stopping-up only to enable the development described in the Schedule to this notice to be carried out in accordance with the planning permission granted by Birmingham City Council on 17th December 1998 under reference N/01709/98/FUL.

## Runnymede Borough Council

**NOTICE OF DESIGNATION OF THE RIVER WEY NAVIGATION WITHIN THE BOROUGH OF RUNNYMEDE AS A CONSERVATION AREA**

Notice is hereby given that on 4th August 1999, the Runnymede Borough Council, acting as Local Planning Authority, made a determination under the provisions of section 69 of the Planning (Listed Buildings and Conservation Area) Act 1990 in respect of land at New Haw, Addlestone and Weybridge, Surrey, described in the Schedule hereto, designating the land as a Conservation Area as defined by the Planning (Listed Buildings and Conservation Areas) Act 1990.

The effects of designation are briefly as follows:

- (1) the demolition of buildings (with certain exceptions) requires the consent of the Local Planning Authority,
- (2) any person proposing works to trees in the area is required to give 6 weeks prior notification to the Local Planning Authority of their intentions;
- (3) the upper limit on permitted development in respect of extensions to dwellinghouses is lowered to 50 cubic metres or 10 per cent (whichever is the greater) to the volume of the original building,
- (4) there are additional controls on exterior cladding and roof alterations.

The boundaries of the Conservation Area are shown on plans available for inspection at the Civic Offices, Station Road, Addlestone, Surrey KT15 2AH, between the hours of 9 a.m. to 5 p.m. Monday to Thursday and 9 a.m. to 4.30 p.m. on Fridays.
