THE EALING (BUS STOP CLEARWAY) (AMENDMENT NO. 7) TRAFFIC ORDER 2000

THE EALING (WAITING AND LOADING RESTRICTION) (SPECIAL PARKING AREA) (AMENDMENT NO. 94) ORDER 2000

Notice is hereby given that the Council of the London Borough of Ealing, hereinafter called the Council, on 20th October 2000, made the above-mentioned Orders under sections 6 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984, as amended. The effect of the Bus Stop Clearway Order will be to designate bus stop clearways, operative at any time, on the lengths of streets specified in Schedule 1 to this notice.

THE HARROW (FREE PARKING PLACES) (DISABLED PERSONS) (AMENDMENT NO. 5) ORDER 2000

Notice is hereby given that the Council of the London Borough of Harrow, on 23rd October 2000, made the above-mentioned Order under sections 6 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984, as amended by the Local Government Act 1985, and all other enabling powers.

2. The general effect of the Order will be to amend the Harrow (Free Parking Places) (Disabled Persons) Traffic Order 1994, so as to introduce or remove Free Parking Places for Disabled Persons lawfully displaying Disabled Persons' Badges, so that:

(a) in the length of street specified in Column 1 of Schedule 1 to this notice only vehicles lawfully displaying a disabled persons badge may wait at any time;

(b) the existing disabled person parking spaces listed in Schedule 2 would be revoked.

3. The prohibitions referred to in paragraph 2(a) above will not apply in respect of anything done at the direction of a police constable in uniform or a traffic warden or with the permission of a parking attendant or other person duly authorised by the Council or in the following circumstances:

(a) the vehicle is waiting for a period not exceeding two minutes or such longer period as a parking attendant may approve to enable a person to board or alight from the vehicle or load thereon or unload therefrom his personal luggage. Provided that if the said person is a person suffering from any disability or injury which seriously impairs his ability to walk, or who is blind the vehicle may wait for so long as may be necessary to enable that person to board or alight from the vehicle or load thereon or unload therefrom his personal luggage; or

(b) the vehicle is waiting owing to the driver being prevented from proceeding by circumstances beyond his control or to such waiting being necessary in order to avoid an accident; or

(c) the vehicle is used for fire brigade, ambulance or police purposes or, not being a passenger vehicle, is being used in the service of a local authority in pursuance of statutory powers or duties provided that in all the circumstances it is reasonably necessary in the exercise of such powers or the performance of such duties for the vehicle to wait in the parking place in which it is waiting; or

(d) the vehicle is waiting only for so long as may be necessary to enable it to be used in connection with the removal of any obstruction to traffic; or

(e) the vehicle is waiting while postal packets addressed to premises adjacent to the parking place in which the vehicle is waiting are being unloaded from the vehicle or, having been unloaded therefrom, are being delivered, or while postal packets are being collected for loading on the vehicle from premises or posting boxes adjacent to the parking place in which the vehicle is waiting or, having been so collected, are being loaded thereon; or

(f) the vehicle not being a passenger vehicle is waiting only for so long as may be necessary to enable it to be used for the purpose of any building operation, demolition or excavation adjacent to the parking place, the maintenance, improvement or reconstruction of the highway or the cleansing of gullies in or adjacent to the parking place, the laying, erection, alteration or repair in or adjacent to the parking place of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telegraphic line or the placing, maintenance or removal of any traffic sign; or

(g) the vehicle is in actual use in connection with the removal of furniture to or from one office or dwelling-house adjacent to the parking place from or to a depository or another office or dwelling-house; or

(h) in any other case the vehicle is waiting for the purpose of delivering or collecting goods or loading or unloading the vehicle at premises adjacent to the parking place in which the vehicle is waiting and the vehicle does not wait for such purpose for more than twenty minutes or such longer period as a parking attendant may approve.

4. 
