THE HAMMERSMITH AND FULHAM (PARKING PLACES, ZONE "X") (AMENDMENT NO. 1) ORDER 200*

THE HAMMERSMITH AND FULHAM (PARKING PLACES, ZONE "Y") (AMENDMENT NO. 1) ORDER 200*

THE HAMMERSMITH AND FULHAM (WAITING AND LOADING RESTRICTION) (AMENDMENT NO. 20) ORDER 2007
CHANGES TO CONTROLLED PARKING ZONES "X" AND "Y"

1. NOTICE IS HEREBY GIVEN, that the Council of the London Borough of Hammersmith and Fulham, on 12th December 2007 made the above mentioned Orders under sections 6, 45, 46, 49 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984 as amended.

2. The general effect of the waiting and loading restriction Order which will come into operation on the 17th December 2007 will be to increase the hours during which the existing waiting restrictions apply and operate between 9 a.m. and 5 p.m. on Mondays to Fridays so that on days when a professional football match is being played at Craven Cottage Football Ground, Stevenage Road ("match days") they include the period between 9 a.m. and 9.30 p.m. on Mondays to Fridays

inclusive that are match days and between 9 a.m. and 5 p.m. on Saturdays that are match days, in addition to the existing restrictions, in all the streets within Controlled Parking Zones "X" and "Y" (as listed in the Schedule to this Notice).

3. The general effect of the parking places Orders which will come into operation on the 17th December 2007 will be, within Controlled Parking Zones "X" and "Y" in the London Borough of Hammersmith and Fulham, to:

(a) provide that the hours during which parking places will operate will be changed so that they operate between 9 a.m. and 5 p.m. on Mondays to Saturdays inclusive that are non-match days, between 9 a.m. and 9.30 p.m. on Mondays to Fridays inclusive that are match days and between 9 a.m. and 5 p.m. on Saturdays that are match days, any such day not being Christmas Day, Good Friday or a Bank Holiday;

(b) provide that on a match day, throughout the operational hours of the parking places, the maximum duration of stay in a parking place by a vehicle displaying a pay & display ticket will be one hour (with no return to the same parking place within one hour);

(c) provide that disabled blue badge holders and motorcycles will be able to park within a parking place on both match days and non-match days for any length of time at no cost;

(d) introduce new "smart" visitor parking permits which will be available to all residents whose permanent address is within Controlled Parking Zones "X" and "Y", and will be for the leaving of their visitors' vehicles in a parking place during the operational hours of Controlled Parking Zones "X" and "Y";

(e) provide that the maximum number of "smart" visitor permits per household will be two;

(f) provide that there will be no cost for the issue of the "smart" visitor permits but that the charge for parking in a parking place whilst displaying a "smart" visitor permit will be £1.50 per hour with a maximum limit of 240 hours per year per household;

(g) provide qualifying disabled residents with a 50% discount on the hourly rate for the entire allocation of 240 hours purchased per year per household;

(h) provide that the "smart" visitor permit will be subject to a minimum top up payment of £7.50 (or £3.75 where the 50% discount described above, applies) for 5 hours;

(i) provide that the charge for parking will be payable in advance either by telephone or the internet;

(j) provide that the charge for parking will be calculated per minute and where the parking period includes a part of a minute it will be rounded up to the next whole minute;

(k) provide that no refund will be given for unused hours purchased and that remaining hours at the end of the year will be rolled over but deducted from the available allocation for the following year.

4. For a period of 6 weeks from the day on which the Orders was made, a copy of the Orders and other relevant documents can be inspected during normal office hours at the **Network Management Team, Highways and Engineering, Environment Department, Town Hall Extension, King Street, London W6 9JU**.

5. Any person desiring to question the validity of the Orders or any of the provisions therein on the grounds that it is not within the powers of the Road Traffic Regulation Act 1984 or that any of the relevant requirements thereof or of any regulations made thereunder, may, within 6 weeks of the Orders being made, make application for the purpose to the High Court.
