### Road Traffic Acts

#### London Borough of Hammersmith and Fulham

THE HAMMERSMITH AND FULHAM (WAITING AND LOADING RESTRICTION) (CONSOLIDATION) AMENDMENT (NO. \*) ORDER 200\*

1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Hammersmith and Fulham propose to make the above mentioned Order under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended by the Road Traffic Act 1991 and the local Government Act 1985.

2. The general effect of the Order would be to further amend the Hammersmith and Fulham (Waiting and Loading Restriction) (Consolidation) Order 2009 so that:

(a) waiting restrictions would apply in certain lengths of Alderville Road, Beaconsfield Terrace Road, Britannia Road, Holmead Road, Hurlingham Road, Imperial Road, Jeddo Mews, King Street, King's Road, Linver Road, Maxwell Road, New King's Road, Rumbold Road, Sawley Road, Sterne Street, Townmead Road;

(b) waiting restrictions would be revoked in certain lengths of Alderville Road, Beaconsfield Terrace Road, Britannia Road, Holmead Road, Hurlingham Road, Imperial Road, Jeddo Mews, King Street, King's Road, Linver Road, Maxwell Road, New King's Road, Rumbold Road, Sawley Road, Sterne Street, Townmead Road.

3. A copy of the proposed Order and the plans which show the location and effects of the Order, and of the Council's statement of reasons for proposing to make the Order, can be inspected at the address below between 9am and 5pm on Mondays to Fridays inclusive, until 6 weeks have elapsed from the date on which either the Order is made or the Council decides not to make the Order.

4. Any person desiring to object to the proposed Order or make representations should send a statement in writing of the objection and the grounds on which it is made within 21 days from the date on which this notice is published to:
