NOTICE OF DESIGNATION OF ORTON CONSERVATION AREA

NOTICE IS HEREBY GIVEN THAT, under the provisions of Section 69 of the Planning (Listed Buildings and Conservation Areas) Act 1990, Eden District Council has designated the following conservation area with effect from 3 August 2009.

Orton Conservation Area, being the whole village of Orton from Mill Dam and track in the north, the properties on Curlew Close in the south, Fair View and the track running behind the properties on Front Street in the west and the track and field boundaries running behind the properties Mill Cote to Orton Hall in the east.

The effect of conservation area designation is to increase controls over the demolition and alteration of buildings, and work to trees, and to assist the local planning authority in preserving or enhancing the special architectural or historic interest of the area through the assessment of applications for development and through other enhancement works. A map showing the boundary of the area may be inspected at the offices of Eden District Council, Mansion House or Town Hall, Penrith, Cumbria, Monday - Thursday 8.45 am to 5.15 pm and Friday 8.45 am - 4.45 pm.

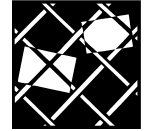
