**THE BEXLEY (WAITING AND LOADING RESTRICTION) (AMENDMENT NO ) TRAFFIC ORDER 20XX**

**THE BEXLEY (BEXLEYHEATH TOWN CENTRE) (PARKING PLACES) TRAFFIC ORDER 20XX**

1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Bexley propose to make the above mentioned Orders under sections 6, 45, 46, 49, and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended by Section 8 of and Part 1 of Schedule 5 to the Local Government Act 1985.

2. The general effect of the Bexley (Waiting and Loading Restriction) (Amendment No ) Traffic Order 20XX would be to further amend the Bexley (Waiting and Loading Restriction) Order 2009 to:-

(a) Introduce 'At any Time' waiting and loading restrictions in parts of Annandale Road, Sidcup; Bedonwell Road, Belvedere; Bedonwell Road, Bexleyheath; Beverley Avenue, Sidcup; Burcharbro Road, Abbey Wood; Cowper Close, Welling; Curran Avenue, Sidcup; Dryhill Road, Belvedere; Gwilliam Close, Blackfen; Lessness Avenue, Abbey Wood; Lyndon Avenue, Sidcup; Merlin Road, Welling; Orchard Avenue, Belvedere; Osborne Road, Belvedere; Pinewood Road, Abbey Wood; Powys Close, Abbey Wood; Queen's Road, Welling; West Heath Road, Abbey Wood; Wickham Street, Welling; Woodside Lane, Bexley; Woodlands Avenue, Sidcup; and Woolwich Road, Belvedere; and

(b) Monday to Saturday inclusive, 8am – 6.30 pm waiting restrictions are introduced in part of Queen's Road, Welling.

3. The general effect of the Bexley (Bexleyheath Town Centre) (Parking Places) (Amendment No...) Traffic Order 20XX would be to further

amend the Bexley (Bexleyheath Town Centre)(Parking Places) Order 2009 to reduce the residents' parking bay in Chapel Road, Bexleyheath to be replaced by 8.30am – 5.30pm Monday to Saturdays inclusive waiting and loading restrictions.

4. Copies of the proposed Orders, the Bexley (Waiting and Loading Restriction) Traffic Order 2009 (and the Orders that have amended that Order); the Bexley (Bexleyheath Town Centre) Parking Places Traffic Order 2009 (and the Orders that have amended that Order); the Council's statement of reasons for proposing to make the Orders and of a map which indicates the length of roads to which the Orders relate can be inspected during normal office hours on Mondays to Fridays inclusive, at the Contact Centre, Civic Offices, Bexleyheath, Kent DA6 7LB.
