A few Days ago the Chevalier de Vial, who commands a Free Company in the Service of the Republick, took, near Givet, about a Thousand Sabres and Carbines, intended for two Regiments of French Hussars. The Transports, with about One thousand Men of the Earl of Drumlanrig's Regiment, arrived the Day before Yesterday at Helvoetsluys from Scotland. The Margrave of Baden Dourlach is likewise arrived from England.
