Moscow, October 14.

N the 10th Instant her Imperial Majesty came hither from Troitza. Yesterday died in the 52d Year of his Age, of a Complication of Disorders, Prince Kourakin, Grand Master of the Horse to

her Imperial Majesty.

Parma, Oct. 26, N.S. The Infant Duke our Sovereign has named the Marquesses Vitali and Pallavicini, and the Counts del Verme and Barrattieri, to meet and compliment Madame the Infanta; upon her Arrival on the Frontiers of this State, she will be met by the Infant Duke and Numbers of the Nobility, who will receive and conduct her to Plaisance, where every thing is ready for her Reception.

Stockholm, Oct. 28. Advices from Finland by the last Post say, that Things remained there in the same Situation they have done for some Time past, and that they enjoyed a perfect Tranquility upon the Frontiers. The Prince Successor, with the Princess his Spouse, came on the 23d from Drotningholm to this City for

the Winter.

Warsaw, Oct. 29, N.S. Orders have been given for several Detachments of Horse and Foot to march towards Latyczewe, to prevent any Persons or Effects coming from Podolia, a contagious Distemper having lately broke out in feveral Parts of that Province, particularly at

Mohilow and Szaragorod.

Vienna, Oct. 29, N. S. The 25th Instant a grand Council was held at Schonbrun in the Empress's Presence, wherein is said a Resolution was taken to march five Regiments of Imperial Troops into Italy, and to complete all her Imperial Majesty's Forces in that Country: And the next Day her Imperial Majesty, accompanied by the Princess Charlotte de Lorrain, came to the Palace of the Favorite, to which Place the Emperor came this Morning from Feldsperg. In the Afternoon their Imperial Majesties went to the Church of St. Peter, and affished at the So-Jemn Procession and Thanksgivings which are made every Year on this Day for the happy Deliverance of this Capital from the Plague in 1679, and towards the Evening they returned to Schonbrun. The Enginier General de Bohn, who was appointed to visit the Fortifications of her Imperial Majesty in Italy, has received Orders to visit those also of Hungary and Croatia. The Chevalier Tron is arrived here in Quality of Ambassador from the Republick of Venice.

Turin, Oct. 31, N.S. A few Days ago an Express arrived here from the Chevalier Osforio, his Sardinian Majesty's Ambassador at the Court of Spain, with the Contract of Marriage between the Duke of Savoy and the Infanta Dona Marie Antoinette, figned by his Catholick Majesty; and the Ratification of the said Contract has already been sent back to Madrid.

Paris, Nov. 7, N.S. The King is expected to come from Fontainebleau to Versailles, with the whole Court, about the 20th of this Month. M. de Fleury has been appointed by his Majesty Intendant of Bourgogne, in the room of M. de St. Contest, appointed Ambassador to Holland. By an Express from Aix we learn, that Madame the Infanta, who arrived there the 22d of last Month, set out the next Day for Antibes.

Hague, Nov. 9, N. S. His Serene Highness the Prince of Orange arrived here Yesterday Morning in perfect Health from the Castle of Loo, and was complimented thereupon by the Members of the Regency, the Foreign Ministers, and other Persons of Distinction. The Assembly of the States of Holland and West Frizeland remains fixed for the 12th Instant.

Hague, Nov. 11, N.S. Yesterday being the Anniversary of his Britannick Majesty's Birthday, it was celebrated here by the Earl of Holderness, his Majesty's Minister to this Republick, with a Magnificence and Joy equal to the grand and happy Occasion. There were present his Serene Highness the Prince of Orange, the Prince of Bade Bade, the Grand Pensionary, the Greffier, the Nobles of Holland, and the Presidents of the several Colleges. Her Royal Highness the Princess of Orange departed Yesterday from Loo, on her Journey to Leewarden, whither the Prince will soon follow her Highness, after having dispatched the Business that detains him at present at the Hague. General Luchesi is lately arrived here from Vienna, who, after some Stay here, will proceed on his Journey to England. M. Durand arrived here on Saturday last, and, it is supposed, will continue here till the Arrival of M. de St. Conteste, who is appointed Ambassa. dor from France to their High Mightinesses.
