Constantinople, February 7. Since the Difgrace of the three principal Officers of this Empire, every Thing has been very quiet, and no further Changes have been made, as were expected. A few Days ago Baron Penckler received an Express from Vienna, with Advice of the Death of the Empress Dowager, which he immediately notified to all the Ambassadors and Ministers residing at this Court from the Christian Powers, and they are all accordingly preparing to go into Mourning on that Occasion.

Algiers, Feb. 12. Three of our Corfairs are returned this Day into Port from a Cruize, and have brought in with them some rich Prizes. The late Success of our Cruizers has encouraged them to fit out more Ships, some of which are

AT the Council Chamber Whitehall, the in such Forwardness, as that they will be soon able to put to Sea. The Corsairs of Tunis have likewise been very successful in some of their late Cruizes, and are getting ready to put to

Sea again with all Expedition.

Naples, March 2. It having been represented to the King, that the Pirates from Barbary greatly obstruct the Navigation upon the Coast of Calabria, Orders have been given for the fitting out, with the utmost Expedition, several Vessels and Xebecks, which will be ready to put to Sea very soon to cruize against them. On the 3d Instant anchored in this Port, from the different Ports of this Kingdom, a Convoy of 40 Vessels, loaden with Provisions for this City. The King has nominated Ten Governors for the Direction of the large Workhouse that is building for the Poor, and has declared himself Prior thereof. Some of the Gentlemen of the Bed-Chamber having neglected their Attendance at Court, his Majesty has strictly ordered, that for the Future, those who neglect their Duty shall not be admitted at Court for four Months.

Petersbourg, March 6. The Empress, in Confideration of the good Services of Count Alexander Iwanowitz Schuwalow, has bestowed on him and his Heirs, the fole Property in the Iron Mines situate in the Districts of Istizsky and Ugosky, and all the Lands belonging to the Imperial Domains in the District of Veronitz, and known by the Name of Wifchagorod, which 'tis faid will bring him in an annual Revenue of Six Thousand Rubles.

Bologne, March 9. Prince Frederick of. Deux Ponts, accompanied by a Retinue of about twenty Persons, arrived here last Saturday Night from Florence. On Sunday his Highness saw every Thing remarkable in this Town, and on Monday Morning early con-

tinued his Route for Germany.

Florence, March 12. On the 10th Instant, agreeable to the Directions from the Court of Vienna, the Funeral Obsequies were performed at St. Lawrence's Church, for the late Empress, by the Archbishop of Florence, and four Bishops of the State; at which Ceremony the Regency, the Foreign Ministers, the Chamberlains, the Senate, the Magistrates, the Military Officers, and the Nobility, were present. On the 9th arrived here from Lucca, on his Journey to Vienna, M. Sardini, Minister from that Republick to their Imperial Majesties.

Genoa, March 13. The Beginning of last Week a French Ship bound for the Morea was drove, by a violent Storm of Wind, against

Tempest three other Ships were cast away off Fiumicino, but we could not learn of what Nation they were of, as not any one Person on Board either of them was saved. The Master of a Ship just arrived here from the Levant says, that a Tripolitan Corsair, for Fear of salling into the Hands of a Venetian Man of War that was in Pursuit of her, had run in amongst some Rocks near Patrasso, where, by Means of a Shallop, she had landed all her Men.

Leghorn, March 15. This Day arrived in this Port, the Emperor's three Ships, last from

Algiers.

Turin, March 16. The Dutchess of Savoy, who has been pretty much indisposed, is now perfectly recovered, and advances happily in her

Pregnancy.

Dresden, March 20. On the 5th Instant, being the King's Name-Day, their Majesties dined at the Prince Royal's, at a Table of thirty Covers; the Nobility and Gentry dining at two other Tables. During the Entertainment several Discharges were made of the Cannon upon the Ramparts; and at Night there was a drawing Room at the Queen's Apartment. The Count de Mozschynsky, one of the Gentlemen of his Majesty's Bed-Chamber, is set out to carry the Order of the White Eagle to the Duke of Wirtembourg.

Copenhagen, March 21. The Talk of the King's Journey to Holstein is renewed, and 'tis expected his Majesty will soon appoint the Lords who are to attend him in that Journey. They are hard at Work upon the two Men of War which are on the Stocks, and near finished, in order to get them ready for launching if possible against the King's Birth-Day, which will be the latter End of this Month. The severe cold Weather and hard Frost we had here for several Days together, is now entirely gone off, and is succeeded by very fine seasonable Wea-

ther.

Vienna, March 21. The Archdutchess, of whom her Imperial Majesty was safely delivered on Friday last, was baptized the same Night by the Name of Mary-Anne, the King and Queen of Spain standing Godsather and Godmother by their Proxies the Prince of Saxe Hildbourghausen and the Princess Charlotte of Lorrain.

Hambourg, March 23. M. de Reventlau, appointed Envoy Extraordinary from the King of Denmark to the Court of France, will fet out from hence To-morrow Morning for Paris.

Berlin, March 27. The King has conferred on M. Hildebrand, eldest Son of the Baron de Rodenberg, the Title of Councillor of War and of the Domains of the Principality of Minden in Westphalia. His Majesty has appointed Captain Wartemberg to be Major to the Regiment of Hussars of Seydlitz. The Margrave of Brandebourg Schwedt, who has resided here for some Time, went on Monday last to take Leave of the two Queens and of the rest of the Royal Family, and set out early the next

Morning on his Return Home. A few Days ago the Margrave Charles went to visit the Count de Rothenbourg, who still continues very much indisposed. By Letters received last Post from Silesia we are informed, that the River Oder has overflowed its Banks in several Places, and done a deal of Damage to all the neighbouring Country, and that even Breslau itself has suffered greatly by it.

Hague, March 31. On Thursday last, being the Anniversary of the Marriage of their Serene and Royal Highnesses the Prince and Princess of Orange, their Highnesses received the usual Compliments on that Occasion. The Letters received by the last Post from Utrecht and Brussels, give us very melancholly Accounts of the great Damages that have been done by the Overslowings of the Rivers Lecq and Senne.
