Moscow, October 28.

ARON Pretlack, Ambassador from the Court of Vienna, being recovered of his late Indisposition, had last Week his Audiences of Leave of the Empress, and the Great Duke and Great Dutchess, and is since set out on his Return to Vienna. The Day after his Departure, Count Esterhasy, who succeeds him in that Embassy, was admitted to his first publick Audience of her Imperial Majesty, and delivered his Credential Letters.

Madrid, Nov. 9. Their Majesties continue at the Escurial. Orders are sent to the different Ports of this Kingdom, to hasten the Equipping the several Men of War and Frigats which are getting ready for the Sea, Part of which are to sail for the West Indies, and the rest are to cruize in the Mediterranean, to protect our Commerce from the Insults of the Corfairs of

Barbary.

Rome, Nov. 10. By a Grant from the Pope, the Town of Matelica is for the future to be deemed a City, and is to enjoy the same Privileges with the other Cities of the Ecclesiastical State. Cardinal Delci is about to rebuild the Cathedral Church of Castelnuovo, for which Purpose he has obtained the Pope's Leave to borrow 10,000 Scudis of the Apostolick Chamber; which Sum is to be repaid in ten Years out of the Revenues arising from that Bishoprick. We are affured that a private Consistory will be held on the 19th Instant at the Quirinal, in which the Pope intends to confer the Archbishoprick of Bologne on M. Malvezzi, his Maitre de Chambre, who is also to be comprehended in the Promotion of Cardinals which is to be made on the 26th Instant. The Chevalier Capello, the new Venetian Ambassador, will make a most magnificent publick Entry into this City as foon as his Liveries and Equipage can be got ready, which are extremely grand. Notwithstanding the Pains taken by the Pope to reconcile the Differences between the Court of Naples and the Grand Master of Malta, those Disputes run so high at present, that we doubt they will be attended with fatal Consequences. The Pope has ordered the youngest Son of the

Duke d'Altemps to be confined in the Castle of St. Angelo, in order to prevent his marrying a Person of mean Extraction.

Stockholm, Nov. 13. A few Days ago the King made a Promotion of Land and Sea Officers, when the Baron de Ungern-Sternberg was raised to the Rank of Field Maishal. Vice-Admiral Ruth was appointed Admiral, and Count Sparre Vice-Admiral. His Majesty at the same Time disposed of some civil Employments, amongst which M. de Klingsporr was appointed Assessor of the Tribunal of Jonkaping. M. de Rhodt, whom the Baron de Malzhan is come to relieve in the Post of Envoy Extraordinary from the King of Prussia, will have his Audiences of Leave of their Majesties and the Royal Family the latter End of this Week, or the Beginning of next, after which he is to fet out for Berlin.

Copenhagen, Nov. 16. The King has appointed M. de Klingenberg to be one of the Chamberlains of his Majesty's Houshold. Last Wednesday the Queen appeared in Publick for the first Time since her lying-in, on which Occasion the Court was extremely numerous and very brilliant. On the 24th Instant two new Men of War are to be launched at the New Holm; and Prince Ferdinand of Brunswick will set out a few Days after for Berlin; but before his Departure it is said his Majesty will confer on him the Order of the Elephant.

Prague, Nov. 16. The Empress-Queen has caused an Ordonnance to be published, prohibiting, on Pain of Fine and Imprisonment, all Artificers, and Students of Universities in this Kingdom, from wearing of Swords for the

Future.

Vienna, Nov. 17. On Saturday Morning last an extraordinary Council was held at Schonbrun, upon some Advices received from London, for which Court a Courier is since dispatched. On Tuesday a grand Conserence was held at the Palace, at the breaking up of which an Express was sent to Moscow, with Dispatches, as 'tis said, relating to a new Subsidy Treaty proposed to this Court and that of Russia, for constantly keeping, in Conjunction an Army of 120,000 Men, always ready to as Occasion may require. On Wednesday in Emperior

Emperor, accompanied by the Hereditary Prince of Modena, and attended by several Lords of the Court, set out for Laintz, in order to take the Diversion of hunting the Wild Boar in the Neighbourhood of that Place. The States of Lower Austria are employe. at present in deliberating upon the Demands made by her Imperial Majesty for the ensuing Year, which differ but very little from those of the preceding.

Anspach, Nov. 18. The Hereditary Prince of this Country, who has been for some Time at the Courts of Berlin, Brunswick, Cassel and Saxe-Gotha, is returned Home in perfect Health.

Paris, Nov. 19. The Departure of the Court from Fontainbleau for Versailles, is put off on Account of the Indisposition of Madame Victoire, whose Disorder proves to be the Small Pox, with which the has been extremely ill for two or three Days past, but 'tis hoped the Worst is over.

Fontainbleau, Nov. 22. Madame Victoire being thought to be in a fair Way of Recovery, the King has given Orders for the Return of the Court to Versailles on Saturday next.

Paris, Nov. 23. The King has ordered Letters Patents to be prepared for dividing the Royal Chamber, lately established, into two Parts, one whereof is to take Cognizance of all Civil Affairs, and those of the Police, and is to fit every Wednesday, Friday and Saturday; and the other is to determine all Criminal Causes, and is to meet every Tuelday and Thursday.

Brussels, Nov. 26. The States of Brabant, who have been for some Time assembled, are at length separated, after having consented to a Poll-Tax, to a Tax upon Chimnies, and to certain Duties upon Tea and Coffee, the Produce whereof is to support a Body of 40000 Men, who are constantly to be kept on Foot in the Low Countries, and to the repairing the Fortifications.

Hague, Nov. 27. Her Royal Highness the Princes Governante has approved of the late Nomination of Burgomasters and other Officers of this Place. The States of this Province are to open their Assembly To-morrow, for which Purpose most of the Members are already arrived. They write from Hoorn in North Holland, that M. Gerard Berkhoudt, having been nomithated to fill up the Post of Secretary of that City, her Royal Highness has given her Confent thereto.
