NOW, THEREFORE, We do hereby Declare, by and with the advice of Our Privy Council, that during the continuance of the War, or until We do give further public notice, the Proclamation issued on September 3rd, 1939, wherein were specified the articles which it is Our intention to treat as Contraband of War during the continuance of the War with Germany, shall be deemed to specify the articles which it is Our intention to treat as Contraband of War during the continuance of the War with Japan.

Given at Our Court at Buckingham Palace, this Ninth day of December, in the year of our Lord one thousand nine hundred and forty-one and in the Fifth year of Our Reign.

A PROCLAMATION

Specifying the Articles to be Treated as Contraband of War in the War with Finland, Hungary and Roumania, respectively.

GEORGE R.I.

WHEREAS a state of War exists between Us and Finland, Hungary and Roumania, respectively:

AND WHEREAS it is necessary to specify the articles which it is our intention to treat as Contraband of War:

NOW, THEREFORE, We do hereby Declare, by and with the advice of Our Privy Council, that during the continuance of the War, or until We do give further public notice, the Proclamation issued on September 3rd, 1939, wherein were specified the articles which it is Our intention to treat as Contraband of War during the continuance of the War with Germany, shall be deemed to specify the articles which it is Our intention to treat as Contraband of War during the continuance of the War with Finland, Hungary or Roumania, as the case may be.

Given at Our Court at Buckingham Palace, this Ninth day of December, in the year of our Lord one thousand nine hundred and forty-one and in the Fifth year of Our Reign.

NOTIFICATION OF A STATE OF WAR
WITH JAPAN.

The following note was addressed to the Japanese Chargé d'Affaires on the 8th December:—

Sir.

On the evening of the 7th December His Majesty's Government in the United Kingdom learnt that Japanese forces, without previous warning either in the form of a declaration of war or of an ultimatum with a conditional declaration of war, had attempted a landing on the coast of Malaya and bombed Singapore and Hong Kong.

2. In view of these wanton acts of unprovoked aggression, committed in flagrant violation of international law, and particularly of Article 1 of the Third Hague Convention, relative to the opening of hostilities, to which both Japan and the United Kingdom are parties, His Majesty's Ambassador at Tokyo has been instructed to inform the Imperial Japanese Government in the name of His Majesty's Government in the United Kingdom that a state of war exists between the two countries.

NOTIFICATION OF A STATE OF WAR WITH FINLAND.

His Majesty's Government in the United Kingdom conveyed to the Finnish Government by means of a note addressed to them on the 28th November by the United States Minister at Helsingfors, as being charged with British interests in Finland, a message in the following terms:—

"On the 22nd September the Norwegian Government delivered to the Finnish Government on behalf of His Majesty's Government in the United Kingdom a message to the effect that if the Finnish Government persisted in invading purely Russian territory a situation would arise in which Great Britain would be forced to treat Finland as an open enemy not only while the war lasts, but also when peace comes to be made; but that if Finland should terminate her war against Russia and evacuate all territories beyond her frontiers of 1939 His Majesty's Government would be ready to study proposals for the improvement of relations between Great Britain and Finland.

"The Finnish Government's reply showed no disposition to respond to this overture nor have they ceased to pursue aggressive military operations on territory of the Union of Soviet Socialist Republics, the Ally of Great Britain, in the closest collaboration with Germany.

The Finnish Government have sought to contend that their war against Soviet Russia does not involve participation in general European war. This contention His Majesty's Government find it impossible to accept.

"His Majesty's Government in the United Kingdom in these circumstances find it necessary to inform the Finnish Government that unless by the 5th December the Finnish Government cease military operations and in practice withdraw from all active participation in hostilities, His Majesty's Government will have no choice but to declare the existence of a state of war between the two countries."

Since the reply of the Finnish Government made it clear that they had not complied with the above conditions, and did not intend immediately to do so, His Majesty's Government took steps to inform the Finnish Government that a state of war would exist between the two countries as from 12.01 a.m. (Greenwich Mean Time) on the 7th December.

NOTIFICATION OF A STATE OF WAR WITH HUNGARY.

His Majesty's Government in the United Kingdom conveyed to the Hungarian Government by means of a note addressed to them on the 29th November by the United States Minister at Budapest as being charged with British interests in Hungary, a message in the following terms:—

"The Hungarian Government have for many months been pursuing aggressive military operations on territory of the Union of Soviet Socialist Republics, the Ally of Great Britain, in the closest collaboration with Germany, thus participating in the general European war and making a substantial contribution to the German war effort. In these circumstances His Majesty's Government in the United Kingdom find it necessary to inform the Hungarian Government that the 5th unless by December Hungarian Government have ceased military operations and have in practice withdrawn from all active participation in hostilities, His Majesty's Government will have no choice but to declare the existence of a state of war between the two countries."

Since the Hungarian Government have returned no reply to this communication, and since the information at the disposal of His Majesty's Government affords no indication that the Hungarian Government intend to comply with the above conditions, His Majesty's Government have taken steps to inform the Hungarian Government that a state of war exists between the two countries as from 12.01 a.m. (Greenwich Mean Time) on the 7th December.

NOTIFICATION OF A STATE OF WAR WITH ROUMANIA.

His Majesty's Government in the United Kingdom conveyed to the Roumanian Government by means of a note addressed to them on the 29th November by the United States Minister at Bucharest as being charged with British interests in Roumania, a message in the following terms:—

"The Roumanian Government have for many months been pursuing aggressive military operations on territory of the Union of Soviet Socialist Republics, the Ally of Great Britain, in the closest collaboration with Germany, thus participating in the general European war and making a substantial contribution to the German war effort. In these cirstances His Majesty's Government in the United Kingdom find it necessary to inform the Roumanian Government that by the 5th December the unless Roumanian Government have ceased military operations and have in practice withdrawn from all active participation in hostilities, His Majesty's Government will have no choice but to declare the existence of a state of war between the two countries."

Since by midnight on the 5th/6th December no reply to this communication had been received from the Roumanian Government, and since the information at the disposal of His Majesty's Government afforded no indication that the Roumanian Government intended to comply with the above conditions, His Majesty's Government took steps at midnight on the 5th/6th December to inform the Roumanian Government that a state of war would exist between the two countries as from 12.01 a.m. (Greenwich Mean Time) on the 7th December.

STATUTORY RULES AND ORDERS, 1941, No. 2023.

BEER

Prohibition, dated December 16, 1941, under section 5 of the Customes and Inland Revenue Act, 1888 (51 & 52 Vict. c. 8), of the use in Beer of certain substances.

Whereas it appears to the satisfaction of the Lords Commissioners of His Majesty's Treasury that Dulcin (para-Phenetyl Carbamide) and the compounds of Dulcin and all other substances being chemical or artificial products which furnish the chemical reactions of para-Phenetyl Carbamide are capable of being used in the manufacture or preparation for sale of Beer and that the use of any of the said substances may affect prejudicially the interests of the Revenue.

Now the said Lords Commissioners, under the power conferred upon Them by Section 5 of the Customs and Inland

Revenue Act, 1888, do hereby prohibit the use of any of the said substances in the manufacture or preparation for sale of Beer.

TRADE BOARDS ACTS NORTHERN IRELAND), 1923 AND 1939.

THE DEFENCE (GENERAL) REGULATIONS, 1939.

FACTORIES (EXAMINATION OF PLANT).

The Ministry of Labour for Northern Ireland hereby gives notice that on the 15th December, 1941, it made an Order under Regulation 59 of the Defence (General) Regulations, 1939. The Order prescribes that the period within which the next examination of specified classes of hoisting and lowering plant or machinery, steam boilers and steam and air receivers is required to be made in accordance with the Factories Act (Northern Ireland), 1938, and the Docks Regulations (Northern Ireland), 1934, may be extended by from three to six months if certificates declaring that the extensions would be without danger have been furnished in the form set out in the Order by firms, companies or associations which undertake periodic

examination of plant or machinery of the classes specified. Any such certificate must be signed by a competent person and be served on the occupier of the factory, and a duplicate must also be served on the Chief Inspector who may, if he thinks fit, annul any such certificate, by service of notice in writing.

Where the Chief Inspector serves notice in writing on a firm, company or association that there should be no postponement of the examination in a particular case, a certificate of the above nature may not thereafter be issued.
