BY THE KING. A PROCLAMATION.

Appointing Thursday the First day of January, one thousand nine hundred and forty-two, a Bank Holiday throughout England, Wales and Northern Ireland for the purposes of the Bank Holidays Act. 1871.

GEORGE. R.I.

WHEREAS We consider it desirable, in the circumstances of the present emergency, that Thursday, the first day of January, one thousand nine hundred and forty-two, shall be kept as a close holiday in all banks in England, Wales and Northern Ireland and shall, as regards bills of exchange and promissory notes payable in England, Wales or Northern Ireland, be deemed to be a bank holiday for all the purposes of the Bank Holidays Act, 1871:

NOW, THEREFORE, in exercise of the powers conferred by section four of the said Act We do by this Our Royal Proclamation, by and with the advice of Our Privy Council, appoint the said first day of January to be observed as a bank holiday throughout England, Wales and Northern Ireland.

And We do declare that this Proclamation does not have the effect of making the said day a holiday under, or for the purposes of the Holidays Extension Act, 1875.

Given at Our Court at Windsor Castle, this eighteenth day of December, in the year of our Lord, one thousand nine hundred and forty-one, and in the sixth year of Our Reign.

GOD SAVE THE KING.

CIVIL AUTHORITIES (SPECIAL POWERS) ACTS (NORTHERN IRELAND), 1922 AND 1933.

Whereas by Regulation 26 of the Regulations contained in the Schedule to the Civil Authorities (Special Powers) Acts (Northern Ireland), 1922 and 1933, it is provided that the Civil Authority may by notice prohibit the circulation of any newspaper for any specified period, and that any persons circulating or distributing such newspaper within such specified period shall be guilty of an offence against the Regulations in the said Schedule:

Now I, the Right Honourable Sir Richard Dawson Bates, Bt., D.L., M.P., Minister of Home Affairs for Northern Ireland, being the Civil Authority under the said Acts, do hereby in accordance with the provisions of Regulation 26 of the Regulations made under the authority of the above-mentioned Acts, prohibit the circulation of the following newspapers entitled:—

- "The Irish World and American Industrial Liberator"
- " Fianna"
- "Republican Congress"
- "An Siol" or "The Seed"

- "Red Hand" and
- "The Critic,"

or under any other title or alias whatever in Northern Ireland from the 1st day of January, 1942, until the 31st day of December, 1942.

ACQUISITION OF SECURITIES TREASURY DIRECTIONS.

The Treasury, in pursuance of paragraph (2) of Regulation 1 of the Defence (Finance) Regulations, 1939, have, by the Acquisition of Securities (No. 6) Order, 1941, transferred to themselves certain sterling securities as specified in that Order.

- 3. Owners of securities affected by the Order whose Stocks are either registered or inscribed at the Bank of Ireland, Dublin, shall without delay cause the Stock to be transferred to the Bank of England register and shall thereafter comply with the directions in paragraph 1 of these Directions.
- 4. Payment shall be made on the 2nd March, 1942, to the bank, stock-broker or other person through whom the securities are delivered provided that delivery of the requisite documents, complete and in order, has been made to the Bank of England on or before the 9th February, 1942. Payments for securities delivered thereafter will be made three weeks after delivery of the requisite documents complete and in order.

5. The Bank of Ireland, Belfast, and any branch in the Isle of Man of Barclays Bank, Limited, Lloyds Bank, Limited, Martins Bank, Limited, or Westmin-ster Bank, Limited, shall be Receiving Banks for the purposes of this Direction.
