BY THE LORDS JUSTICES OF NORTHERN IRELAND.

Dumb. 108

WILLIAM MOORE.

WHEREAS by Section 1 of the Resident Magistrates (Ireland) Act, 1920, it is provided that the Lord Lieutenant may, by Order made with the concurrence of the Treasury, prescribe the rates and scales of salaries and allowances to be paid to Resident Magistrates and the conditions applicable thereto, and, subject to the provisions of the Order, any rates, scales and conditions thereby prescribed shall have effect as from the date therein specified instead of the rates, scales and conditions prescribed by or in pursuance of the Resident Magistrates and Police Commissioners Salaries Act, 1874, or any other Act, or by any previous Order under this section or otherwise:

And whereas by the Government of Ireland Act, 1920, the Orders and Regulations made thereunder and the Irish Free State (Consequential Provisions) Act, 1922, references to the Lord Lieutenant in their application to Northern Ireland are to be construed as references to the Governor of Northern Ireland, and references to the Treasury in their application to Northern Ireland are to be construed as references to the Ministry of Finance for Northern Ireland :

Now we, the Lords Justices of Northern Ireland, in pursuance of the powers conferred on Us by the said Act and all other powers Us thereunto enabling with the concurrence of the Ministry of Finance for Northern Ireland, do hereby order and prescribe that the following rates and scales of salaries and allowances shall be paid to Resident Magistrates, instead of the rates and scales hitherto prescribed and in force:—

(1) A scale of salary, rising from $\pounds 550$ a year by annual increments of $\pounds 20$ to $\pounds 690$ a year, and then by annual increments of $\pounds 25$ to $\pounds 900$ a year, with effect as from the first day of April, 1923.

(2) An allowance of £100 a year in respect of travelling expenses for journeys undertaken on official duty, within a distance of 10 miles from Headquarters.

(3) Subsistence allowance at the rates sanctioned for Civil Servants on a similar scale of salary.

(4) An allowance of £8 a year for postage, stationery and incidental expenses.

Provided that a Resident Magistrate who has been transferred from the Government of the United Kingdom to the Government of Northern Ireland under the provisions of the Constabulary (Ireland) Act, 1922, or who has been appointed by the Government of Northern Ireland, after having previously served as a Resident Magistrate under the Government of the United Kingdom, shall be entitled as from the 1st April, 1923, or from the date of appointment, if later, to payment of salary at the rate which would have been payable to him if the above scale had been in operation from the time of his permanent appointment by the Government of the United Kingdom.

This Order shall have effect as from 1st April, 1923, and the Order of the Lord Lieutenant, dated 10th day of December, 1920, is hereby revoked.

expense of, the Council or the Down County Council:

And it is hereby directed that Notice of this Order having been made, with a statement of its effect, specifying the adaptations as aforesaid, shall be published by the Council once at least in one or more of the newspapers circulating in their District in each of two successive weeks, and by fixing copies thereof in some conspicuous place on or near the outer door of the effice of the Council, and also if the Council so direct in any other public places in the District, and such publication shall be in addition to the publication in the "Belfast Gazette," required by Section 3 (3) as adapted under the Government of Ireland Act, 1920.

RURAL DISTRICT OF NEWTOWNARDS.

To the Council of the Administrative County of Down; to the Rural District Council of the Rural District of Newtownards; and to all others whom it may concern:

WHEREAS by Section 1 of the Public Health (Ireland) Act, 1896, as adapted, it is enacted in effect that the Ministry of Home Affairs for Northern Ireland may, on the application of the Sanitary Authority of any Rural District, by Order to be published in the "Belfast Gazette," or in such other manner as the said Ministry may direct, declare any pro-visions of the Public Health (Ireland) Acts, 1878 to 1890, in force in Urban Districts to be in force in such Rural District or any contributory place therein, and may invest such authority with all or any of the powers, rights, duties, capacities, liabilities, and obligations of an Urban Authority under those Acts, and that such investment may be made either unconditionally or subject to any conditions to be specified by the Ministry as to the time, portion of the district, or manner, during at, and in which such powers, rights, duties, liabilities, capacities, and obligations are to be exercised and attach:

And whereas it is enacted by Section 22 of the Local Government (Ireland) Act, 1898, that all Urban Sanitary Authorities shall be called Urban District Councils, and that for every Rural Sanitary District there shall be a Rural District Council, whose district shall be called a Rural District:

And whereas it is enacted by sub-Section (1) of Section 33 of the said Local Government Act that there shall be transferred to the District Council of every Rural District the business of the Rural Sanitary Authority in the district:

And whereas it is enacted in effect by Section 105 of the Public Health (Ireland) Act, 1878, as adapted, that any Urban Authority may, if they think fit, provide Slaughter Houses, and they shall make by-laws with respect to the management, and charges for the use of any Slaughter House so provided, and that they shall regulate Slaughter Houses within their District; and that any Urban Authority may make by-laws for the decent and seemly conveyance of meat through the public thoroughfares:

And whereas the District Council of the Rural District of Newtownards (which Council is hereinafter referred to as the District Council) has made application to the said Ministry under the said Section 1 of the Public Health (Ireland) Act, 1896, for an Order declaring the provisions of Section 105 of the said Public Health (Ireland) Act, 1878, in force in Urban Districts, to be in force in the said Rural District:

Now therefore, the Ministry of Home Affairs for Northern Ireland, in exercise of the powers vested in it by the Public Health (Ireland) Acts, 1878 to 1907, as adapted, and by all other statutes in this behalf enabling it, doth hereby declare the provisions of Section 105 of the Public Health. (Ireland) Act, 1878, to be in force within the Rural District of Newtownards; and subject to any conditions which the said Ministry may hereafter deem fit to specify in the matter doth hereby invest the District Council with all the powers, rights, duties, capacities, liabilities, and obligations of an Urban District Council under Section 105 of the Public Health (Ireland) Act, 1878, to be exercised and attach within the limits or boundaries of the said Rural District.
