GOVERNMENT OF NORTHERN IRELAND.
 MINISTRY OF HOME AFFAIRS.

Notice is hereby given that the Ministry of Home Affairs by virtue of powers conferred on it by the Motor Vehicles and Road Traffic Acts (N.I.), 1926 to 1934, has made Regulations dated the 29th May, 1942, entitled The Motor Cars (Speed) (Amendment) Regulations, 1942.

The effect of these regulations is to limit the speed of tractors drawing agricultural trailers fitted with metal tyres to 5 miles an hour.

The Regulations provide, in addition, for the operation of agricultural trailers equipped with metal tyres of at least 3" in width on condition that the laden weight of such trailers does not exceed two tons. These trailers need not be fitted with brakes.
