PROPOSAL TO VARY MINIMUM RATES OF WAGES.

Determination by the Ministry of Finance under Section 3 of the Intoxicating Liquor Act (Northern Ireland), 1923, as amended by the Intoxicating Liquor (Finance) Act (Northern Ireland), 1925, and by the Exchequer and Financial Provisions (No. 2) Act (Northern Ireland), 1936, of the rates at which charges are to be imposed in respect of licences for the sale of intoxicating liquor by retail to be granted or renewed during the year ending 30th September, 1943.

In pursuance of sub-sections (3) (b) and (4) of Section 3 of the Intoxicating Liquor Act (Northern Ireland), 1923, as amended by the Intoxicating
