Order in Council, dated 6th August, 1942, approving Resolution passed by the Pharmaceutical Society of Northern Ireland and the Medical Faculty of Queen's University, Belfast, amending Part I of the Fourth Schedule to the Pharmacy and Poisons Act (Northern Ireland), 1925

"That pursuant to Section 1 of the Poisons (Ireland) Act, 1870, as amended by Section 24 (3) of the Pharmacy and Poisons Act (Northern Ireland), 1925, the substance as follows be added to Part I of the Fourth Schedule of the Pharmacy and Poisons Act (Northern Ireland), 1925:-

Para-aminobenzene-sulphonamide, its Derivatives of para-aminobenzene-sulphona-mide having any hydrogen atoms of the para-amino group or of the sulphonamide group substituted by another radical; its salts.
