EARLY CLOSING ORDER.

8 o'clock p.m. 10 o'clock p.m.

Saturday Saturday 10 o'clock p.m. Provided that nothing in this Order shall affect the obligation of every Occupier to close his Shop at 1 p.m. on one week-day in each week for the weekly half-holiday in accordance with Section 4 of the Shops Act, 1912, and that on the day as specified in the notice affixed in his Shop as the day for the half-holiday the closing hour fixed above shall not apply

above shall not apply. The provisions of this Order shall not apply to the seven days immediately preceding Christmas Day or to the Saturday immediately preceding Easter Day in any year.
