### MINISTRY OF HOME AFFAIRS FOR NORTHERN IRELAND. EXPLOSIVES ACT, 1875.

Whereas Sergeant John James Hynes (No. 1184), of the Royal Ulster Constabulary, was on the 30th November, 1942, appointed to be an Inspector for Northern Ireland under the Explosives Act, 1875: And whereas the said Sergeant John James Hynes is no longer available for the duties of Inspector:

Now, I, the Right Honourable William Lowry, K.C., M.P., being the Minister of Home Affairs for Northern Ireland, in virtue of the power conferred on me by Section 53 of the said Act, and of every other power enabling me in this behalf, do hereby order that the said Sergeant John James Hynes shall from this day cease to exercise the powers and perform the duties of an Inspector under the said Act.

### EXPLOSIVES ACT, 1875.
