2. All Shops to which this Order applies shall be closed for serving Customers on the several days of the week at and after the following hours respectively:

PHARMACEUTICAL CHEMISTS, APOTHE-CARIES, CHEMISTS AND DRUGGISTS, AND REGISTERED DRUGGISTS.

All Shops where the Businesses of Pharmaccutical Chemist, Apothecary, Chemist and Druggist, and Registered Druggist are carried on shall be closed for serving Customers on the several days of the week at the following hours respectively:—

CLOSING HOUR. CLOSING HOUR.

Monday . . 7 p m. Tuesday . . 7 p m. Wednesday . 7 p.m. Thursday ... 1 p.m. 7 p.m. 9 p.m. Friday Saturday

Provided that nothing in this Order shall prohibit Sales after Closing Hours of Medicines and Medical

and Surgical Appliances urgently required.

The provisions of this Order shall not apply to the day preceding a General Holiday or the Six Week-days immediately preceding the 25th day of

December in any year.

Provided also that nothing in this Order shall affect the obligation of every Occupier in each of the Businesses mentioned to close his Shop at the hour of One o'clock p.m., on One Week-day in each week, for the Weekly Half-Holiday, in accordance with Section 4 of the Shops' Act, 1912, and that on the day specified on the Notice affixed in his Shop as the day for the Half-Holiday, the Closing hour fixed above shall not apply.
