IN THE HIGH COURT OF JUSTICE IN NORTHERN IRELAND.

KING'S BENCH DIVISION—IN BANKRUPTCY JOHN PARKER, of Clanbrassil, Marino, in the County of Down, Journalist, was on the 3rd day of December, 1943, adjudged Bankrupt.
