CIVIL AUTHORITIES (SPECIAL POWERS) ACTS (NORTHERN IRELAND), 1922 to 1943.

Whereas there is reason to believe that assemblies of person have been or are about to be convened for the purpose of holding meetings or processions in Northern Ireland to commemmorate the rebellion of Easter Week, 1916, or for the promotion of the objects of the Irish Republican Army or any other unlawful Association:

And whereas there is reason to apprehend that such assemblies of persons and the holding of such meetings or processions will give rise to grave disorder or conduce to a breach of the peace or promote disaffection and thereby cause undue demands to be made upon the Police

Now, therefore, I, the Right Honourable Edmond Warnock, K.C., M.P., Minister of Home Affairs for Northern Ireland, being the Civil Authority under the Civil Authorities (Special Powers) Acts (Northern Ireland), 1922 to 1943, do hereby in accordance with the provisions of Regulation 4 of the Regulations made under the authority of the said Acts, prohibit the holding of any such assemblies, meetings, or processions in Northern Ireland during the period from the

29th day of March, 1945, to the 4th day of April, 1945, both dates inclusive.

And whereas the last election of the existing officers' representative was announced in the "Belfast Gazette" on the 10th May, 1940, and it is therefore necessary to make provision for holding a new election:

And whereas it is provided by paragraph 2 of the said Regulations that whenever an election is to be held of the existing officers' representative the Minister of Finance for Northern Ireland shall appoint a person to be Returning Officer:
