MEDICINES, PHARMACY AND POISONS. APPOINTED DAYS.

Order, dated 30th May, 1945, made by the Minister of Home Affairs under Section 40 of the Medicines, Pharmacy and Poisons Act (Northern Ireland), 1945.

Whereas it is provided by Section 40 of the Medicines, Pharmacy and Poisons Act (Northern Ireland), 1945 '(hereinafter referred to as "the Act") that the Act shall come into operation on the appointed day, and that the appointed day shall be such day as the Minister of Home Affairs may appoint, and that different days may be appointed for different provisions of the Act:

Now, therefore, I The Right Honourable Edmond Warnock, Minister of Home Affairs for Northern Ireland, do hereby order as follows:

1. The first day of July, one thousand nine

The first day of July, one thousand nine hundred and forty-five shall, save as here-inafter in this Order provided be the appointed day for the coming into operation

appointed day for the coming into operation of the provisions of the Act.

The first day of July, one thousand nine hundred and forty-six shall be the appointed day for the coming into operation of the provisions of Section 4 of the Act.

The first day of January, one thousand nine hundred and forty-seven shall be the appointed day for the coming into operation of the provisions of Section 10 of the Act.

This Order may be cited as the Medicines.

This Order may be cited as the Medicines, Pharmacy and Poisons (Appointed Days) Order (Northern Ireland), 1945.

PLANNING (GENERAL INTERIM DEVELOPMENT) ORDER (N.I.), 1944.

The effect of the said direction is that the following class of development may not be carried out in the said areas unless an application for permission to carry out such development has been made to and granted by the Council.

"The rebuilding, restoration or replacement of buildings which have sustained war damage, except the carrying out of operations therefor, the cost of which does not exceed £25 or which are immediately necessary in consequence of war damage for avoiding danger to health or preventing the deterioration of any building or otherwise required for temporarily meeting the circumstances created by war damage."

The said direction shall come into force on the 1st day of June, 1945.
