ALLIED POWERS (MARITIME COURTS) FRANCE.

Order dated 11th September, 1945, made by the Minister of War Transport under Section 15 of the Allied Powers (Maritime Courts) Act, 1941 (4 and 5 Geo. 6c, 21).

Whereas by subsection (1) of Section 15 of the Allied Powers (Maritime Courts) Act, 1941, it is provided that where the Minister of War Transport (hereinfter referred to as "the Minister") is satisfied that, in pursuance of any arrangements made on behalf of His Majesty with the government of any Power, any British ship is to be wholly or mainly manned by nationals of that Power, the Minister may by order direct that, for the purposes of all or 'any of the provisions of the said Act, that ship shall be treated as if she were a ship of that Power.

Now, therefore, the Minister, in exercise of the powers conferred upon him by the said Section 15, and of all other powers enabling him in that behalf, hereby orders and directs that, for the purposes of all the provisions of the said Act, the ship specified in the Schedule to this Order shall be treated as if she were a ship of France.
