#### THE MINISTRY OF HEALTH AND LOCAL GOVERNMENT FOR NORTHERN IRELAND. POOR LAW.

BELFAST UNION.

To the Guardians of the Poor of the Belfast Union, and to all others whom it may concern.

WHEREAS the Ministry of Home Affairs for Northern Ireland, in exercise of the powers vested in it by the Poor Relief Acts (Northern Ireland), 1838 to 1937, did by Order under Seal bearing date the 15th day of March, 1939, dissolve the Board of Guardians of the Belfast Union:

AND WHEREAS it is expedient to make further provision for the execution and performance of the powers and duties of the said Board of Guardians and to regulate the salaries of officers appointed to execute and perform the said powers and duties: Now, THEREFORE, the Ministry, in exercise of the powers vested in it by the Poor Relief Acts (Northern Ireland), 1838 to 1937, and of all other powers in that behalf thereunto enabling it hereby

(Northern Ireland), 1838 to 1937, and of all other powers in that behalf thereunto enabling it hereby appoints Henry Diamond, Esquire, O.B.E., M.A., and Llewellyn Drysdale Innes Graham, Esquire, M.B., B.Ch. to exercise and perform all the powers and duties of the Board of Guardians of the Belfast Union and declares that the amount of the salary to be paid to each of the persons so appointed shall be as set forth in the Schedule to this Order and shall be payable in equal monthly instalments to the Ministry out of the rates to be levied for raising the Ministry out of the rates to be leviced for raising the amounts from time to time required for Union charges within the said Union.

This Order shall have effect as and from the 1st day of January, 1946, and the said Orders dated the 28th day of May, 1945, the 18th day of September, 1945 and the 5th day of December, 1945, shall cease to have effect.
