Notice of Proposal to make a Special Order varying and amending the provisions of the Special Scheme of Unemployment Insurance for the Insurance Industry.

The Ministry of Labour for Northern Ireland hereby gives notice that it proposes by virtue of the powers conferred upon it by Section 18 of the Unemployment Insurance Act, 1920, as adapted to Northern Ireland by the Government of Ireland (Adaptation of Insurance Acts) Order, 1922, to make a Special Order varying and amending the provisions of the special scheme for the insurance against unemployment of persons employed in the insurance industry contained in the Schedule to the Unemployment Insurance (Insurance Industry Special Scheme) Special Order, 1921, and in the Unemployment Insurance (Insurance Industry Special Scheme) Special Order (Northern Ireland), 1923.
