#### No. 151, or LONDONDERRY DISTRICT. Tidal and Freshwater Definition of the River Roe, Co. Londonderry.

I, The Right Honourable William Clive Bridgeman, one of His Majesty's Principal Secretaries of State, by virtue and in exercise of the powers and authorities vested in me by the above-recited Acts, and of every other power enabling me in this behalf, have defined and determined, and do hereby define and determine and mark out the boundary between the tidal and freshwater portions of the River Roe in the No. 15<sup>1</sup>, or Londonderry District to be a straight line drawn from the townland of Bellarena in the Parish of Magilligan to the townland of Ballyhenry East, in the Parish of Aghanloo (both in the Barony of Keenaght) along the down stream extremities of the piers of the road bridge known as Roe Bridge.

Note.—The 24th Section of the 26th and 27th Vic., cap. 114, provides that it shall not be lawful for any person to use any Net, except a Landing Net, for the capture of Salmon or Trout in the Freshwater portion of any River, as defined, between the hours of 8 o'clock in the evening and 6 o'clock in the morning, except so far as the same may have heretofore been used within the limits of a several fishery next above the tidal flow, and held under Grant or Charter, or by immemorial usage; and every person offending against the provision of this Section is subject to a penalty not exceeding ten pounds, and to the forfeiture of all Boats, Nets and Gear, used in such illegal fishing.

#### ORDER.

#### CIVIL AUTHORITIES (SPECIAL POWERS) ACT (NORTHERN IRELAND), 1922.

WHEREAS by an Order made by me on the 6th day of April, 1923, all persons within the area of Northern Ireland were ordered and required to remain within doors between the hours of 12 o'clock midnight and 5 o'clock a.m., unless provided with a permit in writing from an Officer of the Royal Ulster Constabulary as therein specified, and the said Order is still in force:

Now I, The Right Honourable Sir Richard Dawson Bates, Miuister of Home Affairs for Northern Ireland, being the Civil Authority under the Civil Authorities (Special Powers) Act (Northern Ireland), 1922, by virtue of the powers vested in me by the said Act and the Regulations made thereunder, and of all other powers enabling me in this behalf, do hereby vary the said Order in so far that on the 25th, 26th, and 27th days of December, 1923, and on the 1st day of January, 1924, the hours during which all persons are required to remain within doors unless provided with a permit in writing as aforesaid shall be the hours between 2 o'clock a.m. and 5 o'clock a.m.;

AND all other provisions of the said Order of the 6th day of April, 1923, shall remain in force during the days specified in this Order;

AND on the 28th, 29th, 30th and 31st days of December, 1923, and from midnight following the 1st day of January, 1924, the hours during which all persons are required to remain within doors unless provided with a permit in writing as aforesaid shall be the hours between 12 o'clock midnight and 5 o'clock, a.m.

#### COLLECTIONS IN STREETS OR PUBLIC PLACES.

#### REGULATIONS MADE PURSUANT TO 6 AND 7 GEO. V., Ch. 31, SECTION 5.

WHEREAS in pursuance of the powers vested in the Inspector-General of the Royal Irish Constabulary by an Act passed in the 6th and 7th years of the reign of His Majesty George V., Chapter 31, Regulations may be made with respect to the places where, and the conditions under which, persons may be permitted in any street or public place in Ireland outside the Dublin Metropolitan Police District to collect money or sell articles for the benefit of charitable or other purposes:

And whereas Regulations as aforesaid were made by the Inspector-General of the Royal Irish Constabulary on the 27th day of June, 1918, and approved by His Excellency the Lord Lieutenant:

And whereas said Regulations were applied to Northern Ireland by the Government of Ireland Act, 1920, and Orders made thereunder:

And whereas the powers exercised by the Inspector-General of the Royal Irish Constabulary are now by virtue of the provisions of the Constabulary Act (Northern Ireland), 1922, exercisable in Northern Ireland by the Inspector-General of the Royal Ulster Constabulary:

And whereas it is expedient that said Regulations should be amended as regards Northern Ireland:

Now I, Lieutenant-Colonel Sir Charles G. Wickham, D.S.O., being the Inspector-General of the Royal Ulster Constabulary, by virtue of the powers vested in me by the Acts and Orders aforesaid, do hereby cancel the Regulations made on the 27th day of June, 1918, and make the following Regulations in substitution therefor :--

1. No collection of money (other than a collection taken at an open-air religious meeting) or sale of any article for the benefit of charitable or other purposes shall be made

in any street or public place in any part of Northern Ireland, unless the person, society, committee, or other body of persons responsible for such collection or sale, shall have obtained a permit from the Commissioner of the Royal Ulster Constabulary of the County Borough or the County Inspector of the Royal Ulster Constabulary of the County in which it is proposed to make such collection or sale.

2. Application for a permit shall be made in writing in the form contained in the Schedule hereto not later than the first day of the month preceding that month in which it is proposed to hold the collection or sale, and every application shall be made in the name of a committee or other body consisting of not less than three persons, who shall be jointly responsible for the collection or sale.

Provided that in the discretion of the Commissioner or County Inspector the period of notice may be reduced in any particular case or class of cases if he is satisfied that there are special reasons for this course.

3. No such collection or sale shall be made except upon the day and between the hours stated in the permit.

4. The Commissioner or County Inspector may in granting a permit limit a collection or sale to such streets or public places or such parts thereof as he thinks fit.

5. No person may assist or take part in any such collection or sale without the authority, written or printed in English, of the person or body of persons to whom a permit has been granted. Every person so authorised shall produce such written or printed authority forthwith for inspection by any member of the Royal Ulster Constabulary on demand.

6. No such collection or sale shall be made in any part of the carriageway of any street; nor shall any collection or sale be made on the footway or in any public place to the obstruction or annoyance of any person in such street or public place.

7. All persons acting as collectors or vendors shall occupy a stationary position at some place on the footway. Not more than two persons shall act as collectors or vendors at the same place, and no person shall collect money or sell articles within 30 yards of the place where any other person or persons are collecting or selling.

8. No person under the age of 18 years shall act or be permitted to act as collector or vendor.

9. No collector or vendor shall use a table for the purpose of any collection or sale so as to cause or be likely to cause obstruction. No table used shall exceed 30 inches in length and 20 inches in width.

10. No collector or vendor shall use a box or other receptacle at the end of a pole intended to reach upper windows or the roofs of conveyances.

11. No collector or vendor shall be accompanied by any animal.

12. No collector or vendor shall importune any person to the annoyance of such person.

13. Every collector or vendor shall carry and present to all contributors or purchasers for the reception of money contributions a box or other receptacle numbered and securely closed and sealed in such a way as to prevent the same being opened or the money extracted without such seal being broken, and into this box or other receptacle all money received shall be immediately placed. All such boxes or receptacles shall be numbered consecutively. Every collector or vendor shall deliver his boxes or other receptacles with the seals unbroken to one of the persons responsible for the proper application of the money received.

14. A collector or vendor shall not carry any collecting box, receptacle or tray which does not bear displayed prominently thereon the name of the fund for which the collection or sale is being made, with the date of the collection, nor any box or other receptacle which is not duly numbered.

15. No payment or reward shall be made to any collector or vendor, or other person connected with the promotion or conduct of such a collection or sale, for or in respect of services rendered in connection therewith.

16. Within one month after the date of any collection or sale the society, committee or other body of persons responsible therefor shall forward, where the collection is held in a county borough, to the Commissioner, and elsewhere, to the County Inspector, a statement in the form contained in the Schedule hereto, with vouchers certified by two officials of the society and audited by its auditor or other responsible person not connected with the fund, showing in detail the amount received and the expenses incurred in connection with such sale, and shall, if required by the Commissioner or County Inspector, satisfy him as to the due and proper application of the proceeds of the collection or sale. The society, committee or other body shall also, The within the same period, at their own expense and after audit, publish, in such newspaper or newspapers as the Commissioner or County Inspector may direct, a short statement showing the name of the society, etc., responsible for the collection or sale, the name of the charity or fund which is to benefit, the date of the collection or sale and the amount collected, the amount of the expenses and the amount distributed to the charity or fund.

N.B.—The foregoing Regulations shall not apply to the selling of articles in any street or public place when the articles are sold in the ordinary course of trade and for the purpose of earning a livelihood and no representation is made by or on behalf of the seller that any part of the proceeds of sale will be devoted to any charitable purpose.

Any person who acts in contravention of any of the foregoing Regulations will be liable on summary conviction to a fine not exceeding forty shillings, or in the case of a second or subsequent offence not exceeding five pounds.



#### CLASSIFICATION OF ROADS.

To the Council of the County Borough of Belfast; and

To all others whom it may concern:

WHEREAS by Section 17 (2) of the Ministry of Transport Act, 1919, as applied by the Government of Ireland Act, 1920, and the Orders made thereunder, it is enacted that for the purpose of advances for the construction, improvement, or maintenance of roads, the roads in Northern Ireland shall be classified in such manner as the Ministry of Home Affairs for Northern Ireland may think fit;

for Northern Ireland may think fit; And Whereas the Ministry have complied with the procedure prescribed by the abovementioned section and have considered all representations made to them by the County, County Borough, and District Councils interested;

Now, therefore, the Ministry of Home Affairs for Northern Ireland in the exercise of all powers in that behalf enabling them hereby declare that the roads in the County Borough of Belfast specified in the First Schedule to this Order shall be Class I roads, and that the roads in the County Borough of Belfast specified in the Second Schedule to this Order shall be Class II roads.

To all others whom it may concern: WHEREAS the Ministry of Home Affairs

WHEREAS the Ministry of Home Affairs for Northern Ireland by an Order under Seal bearing date the 12th day of September, 1922, did order and direct that the Declaration of Allegiance made and subscribed by officers of the aforesaid Committees or Joint-Committees be made in duplicate, and that the duplicate copy be forwarded to the said Ministry within seven days after it has been duly made and subscribed;

And Whereas the said Ministry of Home Affairs by a further Order bearing date the Sixth day of January, 1923, did order and direct that the secretary or clerk of every committee or joint committee wholly or partly appointed by a local authority should, within seven days after the expiration of the period prescribed for the making of the Declaration of Allegiance, furnish to the said Ministry in the appropriate form set out in the Schedule to that Order, or in a form to like effect, a certificate showing whether or not each person elected or chosen or appointed to be a member of the committee or joint committee, as the case may be, had made and subscribed the Declaration of Allegiance within the prescribed time and in the prescribed manner;

And Whereas it appears to the Ministry of Home Affairs for Northern Ireland necessary and proper that the said Orders should be varied in the manuer hereinafter appearing;

Now, therefore, the Ministry of Home Affairs for Northern Ireland in exercise of all powers in that behalf enabling the Ministry hereby orders and directs that the said Orders bearing the dates the twelfth day of September, 1922, and the sixth day of January, 1923, as far as they apply to Educational Committees and Sub-Committees thereof already set up or to be hereafter set up in pursuance of the provisions of the Education Act (Northern Ireland), 1923, Technical Instruction Committees, and School Attendance Committees, shall be varied as hereinafter appearing, that is to say:—

The duplicate copy of the Declaration of Allegiance to be made by officers, and the certificate to be furnished by the Secretary or Clerk of a Committee or Joint Committee relative to the making of the Declaration of Allegiance by persons elected, chosen, or appointed members of Committee, shall be forwarded to the Ministry of Education for Northern Ireland, and not to the Ministry of Home Affairs for Northern Ireland, as directed in the said Orders.

This Order shall come into force on the 1st day of January, 1924.
