HEALTH, SAFETY AND WELFARE.

WHEREAS the Council of the Urban County District of Portadown on the 4th day of September, 1945, submitted a proposal to the Council of the Administrative County of Armagh (in this Order referred to as the "County Council") for the alteration of the boundary of the said Urban County District:

AND WHEREAS the County Council, in exercise of the powers conferred upon them by section twenty-four of the Local Government Act (Northern Ireland), 1934, and of all other powers thereunto them enabling, at a special meeting held on the 30th day of April, 1946, made an order (in this Order referred to as "the Order") giving effect to the said proposal with modifications:

AND WHEREAS the Ministry of Health and Local Government for Northern Ireland (in this Order referred to as "the Ministry") is satisfied that the County Council have complied with the provisions of the said Act and the Urban Districts Boundaries (Procedure) Order, 1936, as to the giving of notice of the provisions of the Order:

AND WHEREAS no appeal has been presented to the Ministry against the Order:

AND WHEREAS it is enacted in effect by subsection (4) of section twenty-four of the said Act that the Order shall be submitted to the Ministry and that the Ministry may confirm the Order without modification or subject to such modifications as the Ministry thinks fit or may disallow the Order:

NOW, THEREFORE, the Ministry in exercise of the powers conferred upon it by section twenty-four of the Local Government Act (Northern Ireland), 1934, and of every other power in this behalf, hereby confirms the Order made by the County Council as set forth in the Schedule hereunto annexed.

Order of the County Council altering the Boundary of the Urban District of Portadown.

ADMINISTRATIVE COUNTY OF ARMAGH.

URBAN COUNTY DISTRICT OF PORTADOWN.

The Local Government Acts (N.I.), 1898-1944
The Urban Districts Boundaries (Procedure) Order, 1936.

Order of the County Council of the Administrative County of Armagh.

ALTERING THE BOUNDARY OF THE SAID URBAN COUNTY DISTRICT.

WHEREAS the Council of the Urban District of Portadown (hereinafter referred to as "the Urban District Council") on the 4th day of September, 1945, submitted a proposal to the County Council of the Administrative County of Armagh (hereinafter referred to as "the County Council" (pursuant to the provisions of Section 24 of the Local Government Act (Northern Ireland), 1934, for an Order for the alteration of the Boundary of the said Urban County District:

AND WHEREAS the County Council, being satisfied that a *prima facie* case had been made out, caused a Local Inquiry to be held on the 26th and 27th days of September, 1945, by a Committee of the County Council:

AND WHEREAS the said Committee made a Report to the County Council that effect should be given to the proposal with modifications:

AND WHEREAS the County Council at their Special Meeting held on the 30th April, 1946, did adopt the said Report:

NOW, THEREFORE, we, the County Council of the said Administrative County of Armagh, in pursuance of the powers conferred upon us by the said Section 24 of the Local Government Act (Northern Ireland), 1934, and of all other powers us in that behalf enabling, do hereby order as follows:—

(1.) The Urban County District of Portadown shall be the area described in the Schedule hereto, and more particularly delineated on the Map submitted to and adopted by us this 30th day of April, 1946, and signed by our Chairman and Secretary,

whereon the area of the said Urban County District is coloured BLUE; and if there be any discrepancy between the Map and the description of the area in the aforesaid Schedule, the Map shall prevail.

(2.) Every person holding office on the 1st day of April, 1947, as County Councillor, District Councillor, or Guardian, for any area affected by this Order, and every County Councillor, District Councillor or Guardian elected for any such area before the 1st day of April, 1947, shall be deemed to have been elected for the area as altered by this Order, and the County Council, District Council, or Board of Guardians of which he is a member shall be deemed to have been elected for the County District or Union as altered by this Order.

(3.) The Bye-Laws at present in force in the said Urban County District shall apply to the area of the said Urban County District as altered by this Order.

(4.) The local and adopted Acts and local Orders in force in the said Urban County District shall apply to the area of the said Urban County District as altered by this Order.

(5.) Notwithstanding the alteration of the boundary of the said Urban County District by this Order the said County Council shall have power to recover arrears of rates in the area affected.

(6.) The financial adjustments consequent upon the making of this Order shall be the subject of an Agreement to be entered into by the parties concerned, such Agreement to be approved by the Ministry of Health and Local Government for Northern Ireland, and in the absence of agreement between the parties shall be determined by the said Ministry.

(7.) The said area shall be the Urban County District for all purposes as from the 1st day of April, 1947.

(8.) This Order may be cited as the Portadown Urban District (Alteration) Order, 1946.

SCHEDULE.

URBAN COUNTY DISTRICT OF PORTADOWN.

DESCRIPTION OF BOUNDARY OF ALTERED AREA.

Commencing at the River Bann at the point "A", where the Townlands of Seagoe Upper, Ballynagowan and Edenderry meet; thence in a northerly direction along the centre of the said river to the point where the townland boundaries of Ballynagowan, Seagoe Upper and Seagoe Lower meet; thence along and around the townland boundary of Seagoe Upper to point "B", where the townlands of Seagoe Upper, Killycomain and Lisnisky meet; thence in a southerly direction along the eastern boundary of the Townland of Killycomain to point "C" where the Townlands of Killycomain, Ballyhannon and Breagh meet; thence along the south boundary of the Townland of Killycomain for a distance of about 1,040 feet; thence southwards along a fence in Levaghery Townland for a distance of about 500 feet; thence south-westwards along fence for about 1,670 feet to a point in Levaghery on the east side of the Portadown-Banbridge road; thence continuing in a northerly direction along the east fence of the said road for a distance of about 390 feet; thence continuing in a straight line across the said road following fences in a westerly direction for a distance of about 795 feet; thence along the centre of the stream south-westwards for a distance of about 685 feet; thence about 480 feet north-westwards along the centre of a stream, and thence continuing along the same stream about 710 feet south-westwards to the River Bann at point "D", a distance of about 380 feet south of the point where the boundaries of the Townlands of Tavanagh, Levaghery and Annagh meet; thence following the centre of the river south-eastwards for a distance of about 2,100 feet to point "E", which is about

320 feet north of the point where the Townland boundaries of Breagh, Levaghery and Annagh meet; thence south-westwards to the river bank; thence in the same direction following the centre of a drain for a distance of about 450 feet; thence in the same direction along the centre of the drain on the south side of a rampart for a distance of about 1,600 feet until it reaches the main line of the Great Northern Railway; thence across the said Railway and continuing in the same direction along the centre of the drain on the south side of a rampart for a distance of about 700 feet until it reaches the Portadown-Tandragee road, about 450 feet north of the point where the said road intersects the boundary between the Townlands of Annagh and Ballyworkan; thence continuing across the aforesaid road in a north-westerly direction and following along fences in a westerly direction for a distance of about 1,000 feet to the Annagh River at point "F", about 580 feet down-stream from the north-western corner of the Townland of Ballyworkan; thence northwards along the Annagh River to the point where the Townlands of Clownagh, Annagh and Maghon meet; thence westwards along the boundary between the Townlands of Clownagh and Maghon to the eastern boundary of the Townland of Kilmoriarty; thence northwards along the boundary between the Townlands of Clownagh and Kilmoriarty to the point where the Townlands of Clownagh, Kilmoriarty and Ballylum meet; thence north-eastwards about 670 feet along the boundary between the Townlands of Clownagh and Ballylum to point "G"; thence north-westwards along a drain for a distance of 170 feet and along fences in the same direction for a distance of about 790 feet to the Portadown-Loughgall road, Route B.77; and continuing in the same direction across Route B.77, and along fences for a distance of about 1,590 feet in a straight line to the Townland boundary on the Ballybay River between Corcullentrabeg and Ballylum at the point "H"; thence in a north-easterly direction along the aforesaid boundary and continuing along the Townland boundary between Selshion and Ballylum and continuing along the Townland boundary between Selshion and Corcrair to where it meets the Townland boundary of Ballyoran at point "K"; thence northwards along the western boundary of the Townland of Ballyoran to where the Townland boundary meets the Portadown to Moy Road, Route B.28, at point "L"; thence across the said road; thence north-eastwards for a distance of about 670 feet and south-eastwards for a distance of about 1,700 feet along the north side of Route B.28 to the western boundary of the Townlands of Garvaghy at point "M"; thence north-eastwards and south-eastwards along the northern boundary of the Townland of Garvaghy to the centre of the River Bann; thence north-eastwards along the centre of the said River to point "A" as first described.
