(NORTHERN IRELAND).**

The Linen and Cotton Handkerchief and Household Goods and Linen Piece Goods Wages Council (Northern Ireland) hereby gives notice of its intention to submit to the Ministry of Labour and National Insurance proposals for the revocation of the First Schedule to the Linen and Cotton Handkerchief and Household Goods and Linen Piece Goods Wages Council (Northern Ireland) Wages Regulation Order, 1946 (S.R. & O. 1946, No. 114) dated 2nd April, 1946, as amended by the Linen and Cotton Handkerchief and Household Goods and Linen Piece Goods Wages Council (Northern Ireland) Wages Regulation Order, 1946 (S. R. & O. 1946, No. 146) dated 16th July, 1946, the Linen and Cotton Handkerchief and Household Goods and Linen Piece Goods Wages Council (Northern Ireland) Wages Regulation (Amendment) Order, 1946 (S.R. & O. 1946, No. 206) dated 29th November, 1946, and the Linen and Cotton Handkerchief and Household Goods and Linen Piece Goods Wages Council (Northern Ireland) Wages Regulation Order, 1947 (S.R. & O. 1947, No. 35) dated 10th March, 1947, and for the fixing of specified statutory minimum remuneration in substitution for the current statutory minimum remuneration.

The Wages Council will consider any written representations with respect to the above-mentioned proposals which may be sent to it within twenty-one days from 25th July, 1947.
