The Civil Service Commissioners for Northern Ireland give notice that the following Regulations are published with the approval of the Ministry of Finance.

REGULATIONS RESPECTING OPEN RECON-STRUCTION COMPETITION FOR THE SITUATION OF ORDNANCE SURVEY ASSISTANT GRADE III (MALE) IN THE CIVIL SERVICE OF NORTHERN IRELAND

### Part I—Candidate's Qualifications.

- 1. A candidate who does not qualify for appointment as a result of the first examination will be eligible to compete at the second examination.
- 2. Every candidate must on the 1st September, 1948, have attained the age of 18 years and must not have attained the age of 26 years: provided that a candidate may deduct from his age for the purpose of bringing it within the prescribed upper limit
  - any time prior to the 3rd September, 1939, served in the Royal Navy, the Army or the Royal Air Force;
  - any time, not exceeding two years, served in an established situation in the Civil Service of Northern Ireland.
- 3. Every candidate must be either a natural born or a naturalised British subject, and must satisfy the

Commissioners that he is ordinarily resident in the United Kingdom.

- 4. Every candidate must have had whole-time continuous and systematic education until the age of 15, but the Commissioners will accept as eligible a candidate, whose whole-time education ended before that age if
  - (a) he has passed the Junior Certificate examination of the Ministry of Education for Northern Ireland, or has attained an educational standard accepted by the Commissioners as equivalent or higher;

(b) he is already serving in an established situation in the Civil Service of Northern Ireland, and is recommended by his Department as a suitable candidate.

Provided that the Commissioners may also accept as eligible a candidate whose whole-time continuous and systematic education ceased shortly before he reached the age of 15, being a candidate who is not eligible under sub-paragraphs (a) or (b) but in no circumstances may they accept under this proviso a candidate whose whole-time continuous and systematic education cased before he reached the age of 14 education ceased before he reached the age of 14 years and six months.

- 5. Every successful candidate must satisfy the Commissioners as to his health and character.
- 6. No person who is undergoing a course of study with the aid of a grant from public funds shall be eligible to compete before the completion of the course, unless he has previously obtained permission to do so from the authority which administers the grant.

### PART II—Application and Examination.

- 7. Every candidate must apply on the appropriate form within the time and in the manner of which notice is given by the Commissioners.
- 8. Every candidate shall pay a fee of 5/- for each examination to which he desires to be admitted. This fee must be paid when the application form is sent in.
  - 9. Each examination will comprise-
    - Written papers in the following subjects, with maximum marks as indicated: English (300), Arithmetic (100), Elementary Mathematics (300), Drawing (200), General Knowledge (100) and General Latellianars (200) Intelligence (200).
    - (ii) Interview (maximum marks 300).
- 10. Those candidates who, from the statements in their application forms, are found to be prima facie eligible will undergo the written examination. Of the candidates who obtain the highest aggregate marks in the written examination a certain number to be determined by the Commissioners will be summoned to the interview, at which an Interviewing Board will award each candidate a mark for his record and personal qualities.
- 11. The order of merit of the candidates will be determined by combining the marks for written examination and interview; and successful candidates must obtain such an aggregate number of marks in the examination as a whole as will satisfy the Commissioners.

- 12. Each candidate shall be examined at such time and place as the Commissioners may determine.

  13. If, on being notified of the date fixed for the first examination, a candidate wishes to defer competing until the second examination, he should apply as soon as possible to the Commissioners, who will consider whether, having regard to the public interest, they can give their consent.
- 14. Where the cost of travel at the lowest rate from any part of the United Kingdom to the examination centre, exceeds £1, the amount of the excess will be refunded to the candidate.

### PART III—APPOINTMENT.

15. It is the intention that of the total number of vacancies to be filled with the two examinations, Service candidates shall receive not less than 50 per cent., provided that a sufficient number reach what is in the judgment of the Commissioners a satisfactory standard of general proficiency.

- 16. For the purpose of Regulation 15 candidates shall be regarded as Service candidates, if they have rendered whole-time service during any period, between the 3rd September, 1939, and the 15th August, 1945, in
  - (a) the Armed Forces of the Crown or
  - (b) the Mercantile Marine or the Merchant Navy;
- 17. The number of successful candidates at each examination shall be determined by the Commissioners, regard being had to the intention expressed in Regulation 15 and to the number and ability of the competitors.
- 18. Of the candidates next in order of merit to those declared successful in the first examination a certain number at the discretion of the Commissioners may be classified as reserve candidates and considered for appointment in conjunction with the results of the second examination.
- 19. Persons upon whose training for the occupation of teacher public money has been spent, cannot be appointed until the consent of the Ministry of Finance has been notified to the Commissioners.
- 20. Candidates may be required to serve anywhere in Northern Ireland.
- 21. Any attempt on the part of candidates to enlist support for their applications through Members of Parliament or other influential persons, except as referees to be named by them in their application forms, will disqualify them for appointment.

The Commissioners further give notice that the Competition to be held under the foregoing Regulations will consist of two examinations, the first of which will be held during August, 1948.

No person will be admitted to the Competition from whom the Secretary to the Civil Service Commission has not received an application in the candidate's own handwriting on the prescribed form which can be obtained from the Secretary. The latest date for the receipt of such applications will be 1st July, 1948.
