BY THE KING A .PROCLAMATION

GEORGE R.

Whereas by the Emergency Powers Act, 1920, it is enacted that if it appears to Us that any action has been taken or is immediately threatened by any persons or body of persons of such nature and on so extensive a scale as to be calculated, by interfering with the supply and distribution of food, water, light, or with the means of forcemetion to denrive the comor with the means of locomotion, to deprive the community or any substantial portion of the community, of the essentials of life, We may, by proclamation, declare that a state of emergency exists:

And whereas the cessation of work in certain sections of the dock industry does, in Our opinion, constitute a state of emergency within the meaning of the said Act:

Now, therefore, in pursuance of the said Act, We do by and with the advice of Our Privy Council hereby declare that a state of emergency exists.

Given at Our Court at Holyroodhouse this twenty-eighth day of June, in the year of our Lord one thousand nine hundred and forty-eight, and in the twelfth year of Our Reign.

A Proclamation

For Appointing Monday, July 12th, 1948, a Bank Holiday and a Public Holiday in Northern Ireland

I, William Spencer, Earl Granville, Knight Commander of the Royal Victorian Order, Companion of the Most Honourable Order of the Bath, Companion of the Distinguished Service Order, Vice-Admiral, Governor of Northern Ireland, by and with the advice of the Privy Council of Northern Ireland in pursuance of the Bank Holidays Act, 1871, the Holidays Extension Act, 1875, and the Irish Free State (Consequential Provisions) Act, 1922, and of

every power Me thereunto enabling, do hereby appoint Monday, the twelfth day of July next, as a special day to be observed as a Bank Holiday and as a Public Holiday in Northern Ireland, under and in accordance with the said Acts, and I do by this Proclamation command the said day to be so observed, and all loving subjects of His Majesty to order themselves accordingly.

Given at Government House, Hillsborough, this twenty-eighth day of June, in the year of our Lord one thousand nine hundred and forty-eight.
