## CONTROL OF EMPLOYMENT ACT (NORTHERN IRELAND) 1939

### EXPIRATION

Order in Council, dated 28th June, 1948, made under section nine of the Control of Employment Act (Northern Ireland), 1939.

BY THE GOVERNOR IN THE PRIVY COUNCIL OF  
NORTHERN IRELAND

GRANVILLE

WHEREAS by sub-section (2) of section nine of the Control of Employment Act (Northern Ireland), 1939 (hereinafter referred to as "the Act") it is provided that the Act shall continue in force until such date as the Governor of Northern Ireland may by Order in Council declare to be the date on which the emergency that was the occasion of the passing of the Act came to an end, and shall then expire except as respects things previously done or omitted to be done.

Now, therefore, I, William Spencer, Earl Granville, Knight Commander of the Royal Victorian Order, Companion of the Most Honourable Order of the Bath, Companion of the Distinguished Service Order, Vice-Admiral, Governor of Northern Ireland, by and with the advice of the Privy Council of Northern Ireland, in exercise of the powers conferred upon me by sub-section (2) of section nine of the Act, do hereby order as follows:—

1. This Order may be cited as the Control of Employment Act (End of Emergency) Order (Northern Ireland), 1948.

2. It is hereby declared that the twenty-seventh day of June, nineteen hundred and forty-eight, is the date on which the emergency that was the occasion of the passing of the Act came to an end.
