Order in Council dated 26th July, 1948, made under sub-section (1) of section nine of the Societies (Miscellaneous Provisions) Act (Northern Ireland), 1940.

The thirtieth day of June, nineteen hundred and forty-eight, is hereby declared to be the date on which the period of the emergency date on which the period of the emergency that was the occasion of the passing of the Societies (Miscellaneous Provisions) Act (Northern Ireland), 1940, came to an end.
  This Order may be cited as the Societies (Miscellaneous Provisions) (End of Emergency) Order (Northern Ireland), 1948.
